## Senator Ludwig asked:

For each building owned or leased by the department:

- a) What is the current occupancy rate for the building?
- b) If the rate is less than 100%, detail what the remaining being used for.

### Answer:

### **DEPARTMENT OF THE ENVIRONMENT**

- (a) Office buildings are 100 per cent occupied. Other buildings are used for seasonal activities and occupation rate varies accordingly.
- (b) Not Applicable.

### FOR THE BUREAU OF METEOROLOGY

- (a) All of the Bureau of Meteorology's buildings leases are 100 per cent occupancy with the exception of 700 Collins Street Melbourne.
- (b) This building has 98 per cent occupancy, with the remaining 2 per cent sub-let to CSIRO.

## **CLIMATE CHANGE AUTHORITY (CCA)**

- (a) The Collins Street Melbourne building which houses Climate Change Authority staff is privately owned and the Authority has no information on occupancy rates.
- (b) Not applicable.

### **CLEAN ENERGY REGULATOR**

- (a) The Clean Energy Regulator's building at 5 Farrell Place, Canberra, ACT was 73.5 per cent occupied.
- (b) The remaining space is used to accommodate staff fluctuations and movements.

## **DIRECTOR OF NATIONAL PARKS**

- (a) All buildings are 100 per cent occupied
- (b) Not applicable.

## **GREAT BARRIER REEF MARINE PARK AUTHORITY**

- (a) Townsville Main Office, Kelleher Place, Reef HQ Aquarium, Dent Island and Lady Elliot Island offices are 100 per cent occupied. The Low Isles office is 66 per cent occupied.
- (b) The remaining 34 per cent of Low Isles Office is a vacant house (former Research Station).

## **MURRAY DARLING BASIN AUTHORITY**

- (a) All leased building space is 100 per cent occupied.
- (b) Not Applicable.

## **NATIONAL WATER COMMISSION**

- (a) The National Water Commission's office in Canberra is 70 per cent occupied.
- (b) The remaining space is vacant and available for sub-lease.
