**Senator LUDWIG asked:**

2040. What is the current staffing profile of the department/agency?

2041. Provide a list of staffing numbers, broken down by classification level, division, home base location (including town/city and state)

**Answer:**

2040. Current Staffing

The ACNC current staffing profile is as per below:

- a. 83 permanent ongoing FTE positions (inclusive of two staff on maternity leave and four long term leavers)
- b. Six non-ongoing positions

Due to fluctuating workloads for ACNC's operations teams, the ACNC has sourced 20 staff on secondment from the ATO and 12 labour hire employees to assist in the short term. These tasks are operational in nature and will more than likely be concluded by 30 June 2014. The ACNC also has two special advisors who assist in the operational functions of the Compliance and Red Tape Reduction teams.

Role of staff: 80% of staff are externally focussed, 20% are internally (business/support) focused.
