Senator BUSHBY asked:

Senator BUSHBY: So who attends those meetings and how many, generally?

Mr King: Approximately 30. We do have invitations that go out to some speakers that provide further information. These are our EL2s, primarily. We do have some other officers who might attend if they have special projects on which to report up to the SLG.

Senator BUSHBY: Where are those meetings generally held?

Mr King: The AVO in the last 12 months embarked on an engagement strategy to visit each of the regional offices at the capital centres.

Senator BUSHBY: Would you mind taking on notice and providing the details of where those meetings were held and how many people attended and from which offices.

Mr King: Okay.

Senator BUSHBY: Can you do the same for the regional office group as well, for their meetings?

Mr King: Yes.

Answer:

The Australian Valuation Office (AVO) has undertaken a series of Senior Leadership Group meetings around Australia in order to engage management and staff and to plan and monitor performance and capability change across the organisation. The AVO is undergoing significant organisational change in order to enhance its revenue generating capability and client service. These meetings provide a foundation for successfully managing this change through sharing knowledge and shaping effective staff and stakeholder communications and engagement strategies.

The location, number of Senior Leadership Group attendees and the normal workplace location of these attendees for Senior Leadership Group meetings is shown below. The meetings were held at various regional centres to enable greater engagement between regional offices and corporate services located in Canberra. Local office staff attended sessions at each meeting to interact with national office managers. Varied meeting locations ensure that there is an enhanced understanding between capital office staff and regional staff of local issues and challenges.
