Question:

1327. Have any reports, budget papers, statements, white papers or report-like documents printed for or by the department been pulped, put in storage, shredded or disposed of?

a. If so please give details; name of report, number of copies, cost of printing, who order the disposal, reason for disposal

Answer:

1327. Yes.

a. A number of publications have been disposed of from the warehouse used to store and distribute ACCC publications. Disposal was authorised by Director Corporate Communications after an audit of warehouse holdings in March to June 2014 identified where warehouse cost savings could be achieved.

Reasons for disposals included:

- very old reports or guidelines
- few or no requests for the publication over the last two years
- legislative or guideline change mean the publication is no longer relevant
- more up to date information is available on the ACCC or AER website.

In all cases library copies were kept, and electronic copies are still available on the ACCC website. Forty-six publications were disposed of (28,921 copies) where the original total cost of printing was \$74,112.
