537. Mr Lattimore: We have got an idea of the issues. Bargaining and agreements was probably the top matter raised by parties. Employment protection, which was mainly unfair dismissal—not so much the general protections—was 91. Wages and conditions, often the minimum wage issue, as I mentioned, and awards were pretty critical. Penalty rates was very common from parts of the industry, and then there were a variety of other issues. I can go through them but they are the principal ones. Senator KETTER: Would I be able to obtain a copy of that document you are referring to there?
