#### **Question:**

Since 1 January 2015:

1920. Has there been any change to the staffing profile of the department/agency?

1921. Provide a list of changes to staffing numbers, broken down by classification level, division, home base location (including town/city and state)

#### Answer:

1920. Yes. Since 1 January 2015, the ATO has rationalised functions such as HR, Finance, the Smarter Data Program, the Review and Dispute Resolution and Governance from business lines across all Groups into centralised structures. Additionally, the ATO has achieved a 4% reduction of Executive Level employees, and a 2.5% increase in the number of APS level employees. This has increased the span-of-control of managers and decreased the classification profile of the agency.

1921. Staffing profile includes ongoing, non-ongoing and casual workforce.
