Question:

For the 2015-16 financial year, please outline:

a) How many staff were employed through labour hire arrangements;

b) Total expenditure on labour hire staff;

c) The contractors or labour hire firms engaged to supply these staff;

d) Total payments to each of the organisations that provided staff through either a labour hire arrangement or other contractual arrangement; and

e) The nature of the work performed by labour hire staff.

Answer:

- (a) The way in which details of staff engaged through labour hire arrangements is recorded in ASIC's systems does not allow for a report to be automatically generated. The effort required to compile the data from supplier invoices would require an unreasonable diversion of resources.
- (b) In the 2015-16 year, ASIC expensed \$15,533,434 relating to labour hire staff.
- (c) The contractors or labour hire firms engaged to supply these staff include those detailed at **Attachment A**.
- (d) Total payments to each of the organisations that provided staff through either a labour hire arrangement or other contractual arrangement is detailed at **Attachment B.**
- (e) Labour hire staff are engaged to assist ASIC undertake work consistent with its regulatory functions. The effort required to provide an itemised list by labour hire engagement would require an unreasonable diversion of resources.
