Workforce Development Fund and Industry Skills Fund

Question

Has the funding within the Workforce Development Fund and Industry Skills Fund been allocated yet?

a. Where was that money allocated?

b. What was the public/private split in terms of recipients of that funding?

c. What are the outcomes in terms of qualifications and jobs or industry areas?

Answer

National Workforce Development Fund (including the Critical Skills Investment Fund)

Funding has been allocated under the National Workforce Development Fund.

- a. Money was notionally allocated in each financial year according to national industry sector priorities decided by the former Government. It also includes administrative funding of \$21 million to Industry Skills Councils to administer the programme.
- b. As at 31 December 2014 enrolments with public sector training service providers accounted for 13.7 per cent of total enrolments. Enrolments with private sector training service providers accounted for 86.3 per cent of total enrolments.
- c. Outcomes:

ii. In the application stage, employers were required to confirm that there was a guaranteed employment outcome. The former Government's contracts did not require data on jobs outcomes to be collected once a project had been approved, therefore actual employment outcomes are unknown.

Industry Skills Fund

The Industry Skills Fund is providing \$624.2 million in administered funding.

- a. The fund opened to applications in January 2015. As at 18 May 2015, more than \$2.5 million has been allocated for training places and skills advice support services.
- b. Details of the public/private RTO split are not yet available.
- c. As the Industry Skills Fund has only recently been opened, no projects have yet been completed.

Funds have been provided directly to businesses to upskill employees. Micro, small and medium businesses make up 92% of recipients of training places.

This focus will provide the right economic incentives to enable businesses to flourish and increase Australia's competitive advantage.
