#### Question

## **Employment service providers roundtables**

How many roundtables have been held with employment service providers? What issues are being raised at those meetings? What actions is the Department taking to address the issues raised? Can you provide us with a list of locations, attendees or all roundtables held in 2016 and to date this year?

#### Answer

The Department has hosted 11 jobactive forums held with jobactive CEO's since the start of 2016. All jobactive provider CEOs are invited to these meetings. CEOs attend or send a representative to these meetings. Other invitees to these meetings include representatives from peak bodies – Jobs Australia and the National Employment Services Association.

At these forums a range of issues are raised and discussed in relation to the services provided under the jobactive Deed. Matters put on the agenda by the Department include: overview of labour markets in each state, Employment Fund, Wage Subsidies, Youth PaTH initiatives (internships, employability skills training, employer mobilization roles and responsibilities), IT update, Work for the Dole, and Seasonal Work Incentives for Job Seekers Trial.
