Dept & all agencies: Staffing recruitment

1) How many ongoing staff were recruited from Additional Estimates in February, 2014 to date? What classification are these staff? 2) How many non-ongoing positions exist or have been created from Additional Estimates in February, 2014 to date? What classification are these staff? 3) From Additional Estimates in February, 2014 to date, how many employees have been employed on contract and what is the average length of their employment period?

#### **Answer**

- 1) 9 = 3 x APS 4, 4 x EL1, 1 x EL2 and 1 x SESB1
- 2) The department does not record the ongoing or non-ongoing status of positions in its establishment. It records the employment status (i.e. ongoing or non-ongoing) of an employee.
- 3) 26 employees have been employed on a non-ongoing contract. The average length of employment is 12.1 months.
