## Question

## Dept & all agencies: Printing

1) How many documents (include the amount of copies) have been printed from Supplementary Budget Estimates in November 2013 to date? a) How many of these printed documents were also published online? 2. Did the Department/agency use external printing services for any print jobs since 7 September 2013? a. If so, what companies were used? b. How were they selected? c. What was the total cost of this printing?

#### Answer

This response covers the period from 18 September 2013 to 31 May 2014.

1) 27 documents were printed, with a print run total of 76,589 copies. Eight of these documents were also published online.

2) The Department of Education used the external printing services of Bluestar Print Group, Bytes n Colours and the Exhibition Centre. These three companies were selected via a tender process conducted by the Department of Human Services, with which the department has a Memorandum of Understanding for printing services. The total cost of printing was \$58,786.97 (GST inclusive).
