Senator O'Neill asked on 4 June 2014, Hansard page 138 Refers to previous Question No ED0270_14 and ED0286_14.

Question

Education Grant program - Grants and Awards

Senator O'NEILL: Thank you. I just wanted to clarify that. I would like to ask some questions around the grants and awards. Is there an easily accessible list of the grants and awards that come under the education grant program? Mr Cook: We can certainly take that on notice. Ms Paul: I think we will have to take that on notice. probably. Senator O'NEILL: Yes. I have been looking around through many documents, and I could not easily access a list. Ms Paul: Yes, I think it has not really been a program; it has been a number of different grants programs. So that is probably why we should take that on notice and give you the list. Senator O'NEILL: There is a fairly substantial amount of money that has been involved in it. But I noticed that \$59.7 million savings are going to be going on over the years in the forward estimates. I was hoping you actually might be able to tell me the grants and awards that are going to be able to be cut by \$59.7 million. Mr Cook: There will not be cuts in some cases; they will be terminating programs. In one case, for example, money was going to, I think, the Rock Eisteddfod. The Rock Eisteddfod has indicated it is no longer continuing. So, it made the decision that it would stop, and therefore there is no requirement for us to fund that program. Ms Paul: So we can give you the breakdown. We would need to take it on notice. We can give you what the componentry is. So all the funding that is part of that saving is not committed funding, so it is not funding that everyone has received. And, as Mr Cook said, some of it represented terminating programs as well. But it probably is easiest to spell that out for you on notice, if that works for you. Senator McKENZIE: On terminating funding, the example you used was that Rock Eisteddfod decided. So, you did not mean 'terminating funding' in the traditional way. Senator O'NEILL: Yes, that is what my next question was. Of that list, could you indicate which ones are self-selecting for termination? Ms Paul: Sure.
