## **Cost of JSA services**

Please provide a breakdown of expenditure during 2012 on the following elements of JSA services, and in each case, the number of people assisted through the year (by Stream and in the Work Experience phase): (a) Service payments by Stream and for the Work experience phase as a whole (b) EPF credits available by Stream and for the Work experience phase as a whole (c) EPF expenditure by providers by Stream and for the Work experience phase as a whole (d) EPF expenditure broken down by expenditure type and number of transactions (e) Outcome payments by Stream and for the Work experience phase as a whole.

## **Answer**

Table 1 provides a count of individual job seekers who were on the JSA caseload at any given point during the 2012–13 financial year.
