Indigenous loading

Question

Senator PATERSON: I would like to know the total Indigenous loading over the forward estimates and the 10 years... Are you able to break that down by each state and territory? Mr Cook: We will have to take that on notice; what I have is national data. Senator PATERSON: It would be good if we could have that in both four- and 10-year increments. I am interested in the total dollar increments, the funding growth percentages and the per student amounts.

Answer

Commonwealth funding provided via the Indigenous loading will total an estimated \$1.4 billion over four years and \$4.2 billion over ten years. The table below shows this by state and territory.

To provide Commonwealth per student funding provided via the Indigenous loading over 4 or 10 years by state, we would have to calculate an averaged amount that not only averages the amount between schools, but also between sectors and years. This would have little value as Commonwealth funding per Indigenous student is increasing each year and significantly varies between sectors depending on the share of the Schooling Resource Standard funded by the Commonwealth.

The table below instead shows Commonwealth funding per Indigenous student provided via the Indigenous loading in 2017, 2021 and 2027 by state and sector. It averages funding across schools in each state sector.
