Answer

The following table provides the estimated total public funding and Commonwealth funding as proportions of the Schooling Resource Standard (SRS) under the *Australian Education Act 2013* for all approved authorities.

The total public funding proportion in the list below assumes state and territory governments are contributing according to the state funding commitments outlined in the National Education Reform Agreement and associated bilateral agreements and final offers from the Commonwealth. The Australian Government cannot confirm this is the case.
