#### **Answer**

The attached spreadsheet outlines the Commonwealth recurrent grants information for non-government schools as at Budget 2014, noting:

- Funding 'per student' is based on full-time equivalent students.
- Under the Australian Education Act 2013 (the Act), the loading amounts are calculated for all students and not on a separate basis for primary and secondary students.
- The Low Socioeconomic Status Student loading amount is calculated as a total and not separately for quartile 1 and quartile 2 students.
- The location status as requested is not available. Under the department's agreement with the University of Adelaide, the department is unable to release the ARIA+ Index scores used.
- The number of full-time equivalent students is used in determining the size loading amount and therefore a discrete indicator of the categories is not available.
- The funding amounts and enrolment figures for 2014 are an estimate as at Budget 2014 and do not include potential recoveries from previous payments.
- Data for some (new) schools is not yet available and therefore loading values will not be able to be calculated until next budget period.

Detailed funding information by base and loadings is available for 2014 however estimated funding calculations for 2015 to 2017 are only available on an aggregated whole of school basis. Data for 2015 to 2017 funding assumes all schools experience the average state sector enrolment growth rates. Detailed base and loadings information becomes available after the commencement of each programme year.

The funding model determines the total funding a school attracts and does not prescribe how funding targeted at particular disadvantage be used. Approved authorities (schools and school systems) are able to, and should, tailor the use of that funding to meet the particular needs within their schools.

Capital grants data is not available at the school level. The funding profile for the Capital Grants Programme as at Budget 2014 is as follows:
