Question

Students with disability loading

Senator O'NEILL: So there is a change on the horizon. It would be very interesting if you could provide a full list of the meetings and consultations that have been undertaken in relation to developing this loading for the students with disability. Ms Paul: Oh gosh—over what time period? There have been so many. Mr Cook: Five years? Senator O'NEILL: How about we start around 7 September 2013—that is a pretty clear line in the sand. Ms Paul: Well, it has been ongoing. Mr Cook: There have been many, many. It has been to Education Council a number of times. There is a joint working group, as you would be aware, that has met; it last met last week. There have been many AESOC meetings. We can provide that.

Answer

All Australian government, Catholic and independent education authorities have been working collaboratively to implement the Nationally Consistent Collection of Data on Students with Disability and to refine the funding loading for students with disability.

This work is being progressed through Education Council (formerly the Standing Council on School Education and Early Childhood), Schools Policy Group (formerly the Strategic Policy Working Group) and through the Joint Working Group to Provide Advice on Reform for Students with Disability (Joint Working Group).

The Joint Working Group, chaired by the Australian Government Department of Education, includes representation from state and territory government education authorities, the Independent Schools Council of Australia (ISCA), the National Catholic Education Commission (NCEC), and the Australian Curriculum, Assessment and Reporting Authority (ACARA).
