Higher education and research reviews since October 2013

Question

How many non-legislative inquiries, reviews, options papers and discussion papers, and consultations have been undertaken by the Department in the fields of higher education and/or research or a combination of the two since the 2013 election?

- What is the total expenditure by the Department on the administration of these reviews?
- How much time does the Department estimate it has spent on administering each of these reviews?
- Does the Department have any indication of how much time universities have put into responding to each the reviews?

Answer

The Department of Education and Training has provided in the table below the names of non-legislative inquiries, reviews, option papers, discussion papers or consultations undertaken by the department in the fields of higher education and/or research or a combination of the two since the 2013 election.

Where possible, the department has provided specific and identifiable costs associated with each item. Primarily these are costs associated with external consultancies to undertake or provide input to these reviews.

Each non-legislative inquiry, review, option paper, discussion paper and consultation has been supported by departmental staff and sought the input of relevant stakeholders, including universities. Specific estimates of departmental time spent on administering each of these reviews and university time spent on responding to each of these reviews are not available and providing such estimates would involve an unreasonable diversion of departmental resources.
