As Special Envoy, you will play an active role in Australia's candidacy for membership of the Human Rights Council (HRC) for the 2018-20 term, with a focus on advancing our HRC campaign priorities of good governance, freedom of expression, gender equality, the rights of indigenous peoples, and national human rights institutions. You will also promote our broader human rights agenda, including abolition of the death penalty.

As you know, our campaign for a HRC seat is contested – we are competing with France and Spain for two available seats. The Special Envoy will advocate our claims at key international events and in select countries, including in Africa. Your advocacy will complement the work of Department of Foreign Affairs and Trade officers in particular countries and regions, and also the efforts of our permanent representatives in Geneva and New York in cultivating relationships with HRC members.

While you are a Member of Parliament, you will not receive any remuneration as Special Envoy but DFAT will reimburse the costs of travel and other expenses incurred by you in the performance of the agreed duties as Special Envoy, in accordance with applicable legislative requirements. This appointment will commence with immediate effect and continue until terminated by notification in writing from me, or by prior agreement. In relation to any part of the term of appointment that might occur after you cease to be a Member of Parliament, further consideration will be given to appropriate arrangements.

Answer

- 1. The department organises an annual visit by Canberra-based Heads of diplomatic missions (HOMs) to a regional centre to showcase the business and investment environment and to foster overseas networks. Eighty one HOMs participated, reflecting their strong interest in the broad array of economic opportunities on offer in Tasmania. This was the largest ever group to travel with an Australian Foreign Minister-led visit and provided an excellent opportunity to showcase Tasmania's rich arts and culture, innovative maritime and scientific industries, enterprising agricultural and local businesses and dynamic investment environment. The total cost of the 2016 Diplomatic Corps visit to Tasmania was \$124,673.90.
