- c) From 24 July 2014, the official overseas travel entitlement of the Leader of the Opposition was limited to a class no higher than business class. Previously, there was no limit to class of travel, other than the extent of the entitlement budget.
- d) On 21 July 2014, the Special Minister of State wrote to the Leader of the Opposition advising of the Government's intention to limit the class of his official overseas travel entitlement to a class no higher than business class. In August 2014, the Department of Finance wrote to the Leader of the Opposition confirming that, with effect from 24 July 2014, the official overseas travel entitlement of the Leader of the Opposition is limited to a class no higher than business class.
