[•] Where 'implemented' (columns B, C, F) is greater than 'decisions taken' (columns A, E), the portfolio has in net terms more regulatory costs than savings yet to be implemented. In these cases, 'yet to be implemented' (columns D, G) is less than zero.

^{• &#}x27;Implemented' only captures regulatory decisions that have been fully implemented. Measures that have been progressed but are not yet fully implemented are captured in the 'yet to be implemented' column. For example, implementation of 22 recommendations of the independent review into the 457 visa programme (reported at Autumn Repeal Day with a regulatory saving of \$29.9 million) is continuing. The majority of the reforms is expected to be progressed by the end of Financial Year 2015-16.
