#### **Question:**

- 1. The Tiwi Land Council signed an Agreement to Lease Framework with the Land Development Corporation in December 2014. What are the statutory requirements of the Tiwi Land Council to provide information to the traditional on the nature and purpose of this Lease?
- 2. What were the nature and length of the consultations with the traditional owners?
- **3.** Were women traditional owners consulted on the nature and purpose of the Lease?
- **4.** How long did the traditional owners have to consider the proposal of the lease agreement before it was finally agreed to?
- **5.** For this lease to be finalised it must receive the consent from the Federal Minister under the Land Rights Act. Was this consent given?
- **6.** What is the responsibility of the Tiwi Land Council in ensuring that the terms of the lease are upheld?
- **7.** What are the reporting requirements of the Tiwi Land Council to the traditional owners in relation to this lease?
- **8.** What are the statutory reporting requirements of the Tiwi Land Council to the Minister for Indigenous Affairs in relation to this Lease Agreement?

#### Answer:

1. No lease/s has/have been agreed to or signed. The TLC negotiated and signed a Tiwi Development Framework Agreement with the Land Development Corporation, which

sets out the processes (statutory and otherwise) required should there be a desire by traditional owners to lease land through LDC for economic development. The Framework Agreement was developed over a period of extensive consultation with traditional owners (see below). There is no 'Agreement to Lease Framework', the correct name is the 'Tiwi Development Framework Agreement'.

Along with the aforementioned, staff of the Land Development Corporation have attended various locations across the Tiwi Islands, meeting with a range of traditional owners, clan groups and community members on a total of 27 other dates across <u>all</u> Tiwi communities during the period October 2013 – December 2014.

LDC/NTG Staff will also be attending future meetings with relevant land owning groups, including TLC Executive meetings and the next meeting of the Full Land Council in July for further consultation.
