### **Question:**

The aim of the VTEC Programme is to secure up to 5,000 guaranteed jobs by December 2015. Is this target on track to be met?

- a. How many jobs have been secured for Indigenous jobseekers through the VTEC Programme to date?
- b. How many participants have not been offered or taken up a paid position with an employer?
- c. How many participants who began employment did not achieve a 26 week outcome?
- d. Provide a list of outcomes and payment totals for each of the 29 VTECs.

### Answer:

The Department is working closely with VTEC providers and GenerationOne to support progress to the target. There have been 2723 commencements into the VTEC programme.

- a. To date 1,978 Indigenous job seekers have commenced employment.
- b. The Department of the Prime Minister and Cabinet cannot quantify how many participants have been offered employment, but not commenced a paid position with an employer. To date 192 participants have left the programme before commencing employment.
- c. A total of 237 participants have commenced employment, but did not achieve a 26 week employment outcome.
