- 1. Why did the Board sack Mr Geoff Dixon, the Chair of Tourism Australia and former CEO of Qantas?
- 2. Why did the Board sack Mr Richard Longes, former Deputy Chairperson Lend Lease International, once owners of Ayres Rock Resort, and now Chairperson of Investec?
- 3. Why did the Board sack Mr Peter Barge, former Chairman of Jones Lang LaSalle Hotels and CEO of Asia Pacific, Jones Lang LaSalle and one of Australia's most knowledgeable international hotel and tourism experts?
- 4. Why did the Board sack Mr Ron Morony PSM, former long serving CEO of Indigenous Business Australia, Director of NT Tourism Commission and Chair of The NT Indigenous Economic Advisory Council? What skills in Indigenous business development, including hotel, tourism and marketing, was he lacking? Who amongst the replacements on the Voyages Board can match his skills and experience?
- 5. In relation to Owen Cole's appointment to the Board, can the ILC confirm if this is the same Mr Cole who was found guilty of aggravated assault in 2009 following a brawl at a football match and in which the magistrate described Mr Cole's behaviour as, "thuggery of the highest order"?
- 6. Why did the Board not continue with Mr David Baffsky AO, the former Chair of Accor Asia-Pacific and Asia Pacific Hotelier of the Year 2005-current Director Singapore Airports Corporation and recognised as one of the leading tourism experts in Australia, as Chair of Voyages?
- 7. Has the ILC estimated the current value of Voyages post the negative talk about the resort's viability and negative headlines in the media? The initial write down was estimated at \$62 million. Has the additional write down for the company been calculated since the public disparagement of the resort?
- 8. What will happen to the 300 or so Indigenous employees at the resort? Can their jobs be guaranteed? How can this be done? What of their skills and experience?

- 11. Did Mr Dillon have any prior involvement with ILC in any capacity? If so, can the ILC provide the details and dates of any previous positions in which Mr Dillon had dealings or involvement in issues with the ILC in some other capacity?

The current ILC Board has never disparaged or criticised the operation of the Resort.
