# SENATE STANDING COMMITTEE ON LEGAL AND CONSTITUTIONAL AFFAIRS AUSTRALIAN FEDERAL POLICE

#### Question No. 255

## Senator Ludwig asked the following question at the hearing on 24 February 2014:

In relation to executive coaching and/or other leadership training services purchased by each department/agency, please provide the following information from Supplementary Budget Estimates in November 2013 to date:

- 1. Total spending on these services
- 2. The number of employees offered these services and their employment classification
- 3. The number of employees who have utilised these services, their employment classification and how much study leave each employee was granted (provide a breakdown for each employment classification)
- 4. The names of all service providers engaged. For each service purchased form a provider listed under (4), please provide:
  - a. The name and nature of the service purchased
  - b. Whether the service is one-on-one or group based
  - c. The number of employees who received the service and their employment classification
  - d. The total number of hours involved for all employees (provide a breakdown for each employment classification)
  - e. The total amount spent on the service
  - f. A description of the fees charged (i.e. per hour, complete package)
- 5. Where a service was provided at any location other than the department or agency's own premises, please provide:
  - a. The location used
  - b. The number of employees who took part on each occasion (provide a breakdown for each employment classification)
  - c. The total number of hours involved for all employees who took part (provide a breakdown for each employment classification)
  - d. Any costs the department or agency's incurred to use the location
- 6. In relation to education/executive coaching and/or other leadership training services paid for by the department what agreements are made with employees in regards to continuing employment after training has been completed?
- 7. For graduate or post graduate study, please breakdown each approved study leave by staffing allocation and degree or program title.

### The answer to the honourable senator's question is as follows:

- 1. \$138,486.83 value for total spend, including GST. This figure is for corporate executive coaching and leadership training services purchased by the agency. This includes the jurisdictional fee of \$34,034.41 to Australian Institute of Police Management (AIPM) for FY2014.
- 2. The total number of employees offered the service is 77 and their employment classification is Band 6, Band 7, Band 8(EL1), Executive Level (EL2), and Senior Executive Service (SES) 1 and 2.
- 3. The number of employees who have utilised these services is 40. These programs are undertaken during business hours therefore no study leave is provided.
