

## QUESTION TAKEN ON NOTICE

### BUDGET ESTIMATES – 26 – 27 MAY 2014

#### **(BE14/120) PROGRAMME – 1.2: Visa and Citizenship**

Senator Carr (L&CA 86) asked:

Senator KIM CARR: Thank you. And by state—a breakdown of people working on 457 visas by state?

Dr Southern: Yes, we will take that on notice.

Senator KIM CARR: And by industry group?

Dr Southern: Yes. You mean by state by industry group—a matrix?

Senator KIM CARR: By state and by industry group.

Dr Southern: I think we can do that. We will take it on notice.

Senator KIM CARR: And by manufacturing sector?

Dr Southern: Right. We will take it on notice and see what level of detail we have.

Senator KIM CARR: Can you tell me the number by labour hire company?

Dr Southern: Yes, I believe we can give you that number.

*Answer:*

The requested information for primary visa holders is in the table below. Sponsors self-identify with an industry classification when lodging a nomination or sponsorship and as such, the industry classification shown is based on what the sponsor has recorded. In addition, businesses may self-identify as ‘Other Services’<sup>1</sup> where they operate in more than one industry, or where they cannot easily categorise their industry against the provided options which are based on the Australian and New Zealand Standard Industrial Classification system administered by the Australian Bureau of Statistics.

<sup>1</sup> According to the Australian and New Zealand Standard Industrial Classification, developed by the Australian Bureau of Statistics and Statistics New Zealand, the Other Services Division includes: a broad range of personal services; religious, civic, professional and other interest group services; selected repair and maintenance activities; and private households employing staff. Units in this division are mainly engaged in providing a range of personal care services, such as: hair, beauty, diet and weight management services; providing death care services; promoting or administering religious events or activities; or promoting and defending the interests of their members.
