Senator Xenophon (Written) asked:

The Department's Book 9 Temporary Work (Skilled) (subclass 457) visa emphasises that: "The Temporary Work (Skilled) (subclass 457) visa is designed to enable employers to address labour shortages by bringing in genuinely skilled workers where they cannot find an appropriately skilled Australian." It has been suggested that, for example, in the nursing profession, that the numbers of nurses entering the country on 457 visas is such that the remaining vacancies are now so low that the great majority of nurses graduating from Australian training courses are unable to find entry-level nursing employment. Can you please advise:

- 1. How many foreign nurses have been granted 457 visas over each of the past three years?
- 2. What was the projected vacancy levels for nurses in Australia over each of the past three years?
- 3. What mechanisms does the Department utilise to estimate the likely net vacancies for nurses before approving 457 visas?
- 4. Do those mechanisms include projections for the number of Australian graduate nurses entering the system at the conclusion of their studies?
- 5. In establishing 457 quotas for each employment category, what is the Department's general strategy in matching quotas to projected net vacancies? Do you plan a rough match, a deliberate over-supply or a deliberate under-supply?
- 6. In regard to aviation-related occupations, please advise the number of 457 visas granted over each of the past three years for the following categories:
