(BE17/160) - Functions – Department - Internal Product (DIBP)

Senator Bilyk, Catryna (L&CA) written:

In relation to expenditure on any functions or official receptions etc. hosted by the Department or any agencies within the portfolio since 1 March 2017, can the following please be provided:

- List of functions;
- List of attendees;
- Function venue;
- Itemised list of costs (GST inclusive);
- Details of any food served;
- Details of any wines or champagnes served including brand and vintage; and
- Details of any entertainment provided.

Answer:

Official hospitality is defined in the Department as the use of relevant money to provide refreshments, entertainment, gifts or other benefits to persons other than departmental officials, to facilitate business with external organisations or individuals with related vocational, technical, business or national interests in common with the Department. There is significant guidance available to staff regarding the circumstances when official hospitality is appropriate and specific delegations for approval. Each business area is required to acquit and report events for inclusion in a central register as they occur.

Specific instructions apply to situations where alcohol is served at a function including the requirement to obtain the approval of an SES official. Officials must be aware that they are on duty during events and are subject to the requirements set out in the Department's Drug and Alcohol Policy.

A list of official functions is provided at **Attachment A** – Extract from DIBP Official Hospitality Register 1 March 2017 to 31 May 2017.

In accordance with the *Privacy Act 1988*, the disclosure of personal information, such as names or similar identifiers, may only be released with the consent of the individual being named. For consent to be in place the individual must be fully informed and the consent cannot be coerced. To obtain this consent would require an unreasonable diversion of resources.

The following information is not maintained in the Department's central register:

• itemised list of costs for each event

- menus
- entertainment provided
- the type, brand and vintage of alcohol served.

To provide this information would require an unreasonable diversion of resources.
