Re: Invitation to Participate in Conference on "Religion, Law, and Social Stability," to be held on October 4-7, 2015, at Brigham Young University, Provo, Utah

Dear Commissioner Wilson:

We are delighted that you can be with us for the Twenty-Second Annual International Law and Religion Symposium on October 4-7, 2015. This letter is to inform you about some of the symposium details, provide you with information about possible flight arrangements, remind you of certain United States visa policies, and request information that will allow the symposium to run smoothly.

• Registration Form. If you have not returned the completed Registration form, we would like to ask that you do so immediately. If you have not already done so, please provide a brief one-paragraph bio as well as a personal photograph which will be compiled prior to the symposium. You may also register online at

https://www.law.byu.edu/ICLRS/Symposium Delegate Registrat ion. If you have already done so, please ignore this request.

• Symposium Format. We anticipate papers and panel discussions that will explore the theme of the conference. In particular, the conference will address religion and social tensions, religious freedom and social stability, religion and the rule of law, and religious freedom and foreign policy. Some

presentations will examine this issue from a cross-cultural comparative perspective; others will provide comparative perspective by focusing on current developments in particular countries. Still others will focus on questions faced by public officials responsible for dealing with religious affairs in their respective countries.

- Presentation. As indicated in your initial invitation, we anticipate that you will be participating in a panel presentation at the conference. Most of these panels have a regional focus. We have found that these are most productive when initial comments are limited to 10-15 minutes and the bulk of the time is available for discussion among the panel members. Our expectation is that this will enable you to be free to talk about issues that you know best and that seem most significant from your vantage point and at the same time will promote a very fruitful discussion at our conference. We will welcome extended written submissions after the symposium that can give more thorough treatment of the issues you decide to address. These will be considered for inclusion in our Law Review, and provided that you concur, will also be posted on our Center's website.
- *Translation Needs*. To help you both in making your presentation and being able to enjoy the other delegates' remarks, it is possible for us in most cases to provide translation both into and from your language if you so desire. Obviously, if you are completely comfortable in English, there is no need for us to do so. Please advise us of your preference at your earliest convenience so we can make the necessary arrangements.
- Speeches and papers. We have found that our translators can better prepare themselves if they have a draft or outline of the presentations beforehand. Thus, we would ask you to send us either an outline or draft of your presentation by September 15, 2015. Please note that your outline or draft may be in either electronic or printed ("hard copy") format, and does not need to be in final publishable form. Electronic versions are preferable; we use either Microsoft Word or WordPerfect. Attaching documents to e-mail transmissions should work. Please email your draft or outline to Deborah A. Wright at <a href="www.wrightde@law.byu.edu">www.wrightde@law.byu.edu</a>.
- Reimbursement of Costs. As we mentioned in the invitation letter you received, we will cover all of your travel, lodging, and meal expenses. Our funding is, of course, limited; we can only cover economy class air travel. If you have other business to take care of while in the United States, we would be happy to facilitate that, but we are unable to cover costs beyond those stemming from the itinerary necessary for your conference attendance. All airline tickets will be purchased thru the BYU Travel Office unless prior arrangements are made with Deborah Wright. Should an agreement be made for you to purchase your tickets, in order to be reimbursed, you will need to provide bank wire information, including bank name, bank address, customer name, customer account number, and SWIFT code. When we receive your original receipts, your reimbursement will be wired to your bank account. \*\*\*Reimbursements will not be made at the conference.\*\*\*
- Airfare and Travel Arrangements. Unless you indicate otherwise, we will assume that you would arrive in Salt Lake City on Friday, October 2, 2015, and that you would depart Utah on Wednesday, October 7, 2015, after 4:00 p.m. for your return to

Sydney, Australia.
