The stakeholder consultation process undertaken to develop the strategic plan is explained at page 8 of the plan. AMPC reviews and updates the strategic plan annually. The AMPC partners with research providers to consider the latest developments in science and technology to help determine priorities for investment, in addition to considering ideas and proposed programs from meat processor members and industry stakeholders. AMPC also engages with the Australian Government to ensure effective alignment and delivery of industry and government priorities and the integration of (Research Development & Extension) RD&E activities that benefit the industry and broader community.

The Portfolio Development Process provides a mechanism by which AMPC establishes a balanced portfolio for investment. This process requires engagement with a broad array of stakeholders, including the processor-member based Program Advisory Committees.
