Senator STERLE asked:

Senator GALLACHER: Do not assume that I recall questions. I do eight days of this with different jurisdictions and departments, so do not assume that I am going to recall anything.

Mr Tucker: Perhaps not the answers, but certainly the questions. The scheme did open at different times in different jurisdictions. I think it is fair to say, certainly with Queensland and New South Wales—and we can give you those dates in just a moment—and Victoria, that they had existing institutional structures and that enabled us to start in advance with many of the jurisdictions. We had to do quite a lot of work with them to establish the appropriate arrangements and that did take some time.

Senator STERLE: Can I clarify something?

Senator GALLACHER: Absolutely.

Senator STERLE: Chair, just through you, of the applications, the successful ones and whatnot, this is part of the \$420 million concessional loan? It is not the \$280 million drought-specific.

Mr Tucker: Farm finance loans.

Senator STERLE: Thanks, Senator Gallacher.

Senator FARRELL asked:

Ms Freeman: Senator, if I may finish off an answer to a question that you asked in the previous session about how much money had gone out for the interim farm household allowance. I wanted to let you know. The amount that is currently allocated to the program is \$13.6 million for 2013-14. We do not have the actual numbers that have gone out thus far, but we can certainly take that on notice.

Answer:

Interim Farm Household Allowance replaced the Transitional Farm Family Payment on 1 March 2014. Recipients in receipt of Transitional Farm Family Payment on 28 February 2014 automatically transferred to Interim Farm Household Allowance.

The amount of income support which has been paid to farmers under these two programs from 1 July 2013 to 30 June 2014 is \$12.5 million. This comprises \$5.0 million for Transitional Farm Family Payment and \$7.5 million for Interim Farm Household Allowance.
