Answer:

- AFMA regularly exchanges Southern Ocean surveillance and enforcement information with New Zealand and AFMA deployed a fisheries officer on the first New Zealand Southern Ocean patrol.
- 2. AFMA regularly exchanges Southern Ocean surveillance and enforcement information with France and deploys officers on board all French patrols to the Southern Ocean.
- 3. AFMA has participated in two multi-lateral surveillance and enforcement operations in or near the Southern Ocean resulting in the apprehension of two IUU vessels. The countries involved were France, the United Kingdom and South Africa. AFMA also cooperates with port states in South East Asia to minimise opportunities for Southern Ocean vessels to unload illicit catch and take on supplies to support illegal fishing operations.

This has led to:

- vessels being intercepted, investigated or denied port access in Indonesia, Malaysia and Singapore
- IUU vessels being deregistered by their flag state
- legal action being taken by the countries whose nationals have been identified as being on board IUU vessels.
- 4. AFMA plans to continue working with counterpart agencies in countries which have an interest in combatting IUU fishing in the Southern Ocean and deploying officers on Southern Ocean patrols.
- 5. AFMA has deployed officers on three (3) French patrols in 2012-13 and two (2) French patrols in 2013-14 to the Southern Ocean (to 1 December 2013).

 AFMA draws from its total pool of officers to provide patrol officers, IUU port interdiction and international cooperation activities. The number of officers committed to the program will vary at any one time based on risk and activity levels.

Does AFMA encourage or speak to industry about supporting the expansion of the domestic fishing industry?

Answer:

Yes.

Australian Fisheries Management Authority (AFMA) works closely with industry, scientists & other experts and stakeholders to develop sustainable fisheries resources to optimise net economic returns to the Australian community. Rebuilds of fish stocks previously subject to overharvest has allowed sustainable expansion in a number of major AFMA-managed fisheries. A system of statutory fishing rights provides industry with a secure foundation to underpin investment in the Commonwealth fishing industry.

In addition to supporting the sustainable development of well-known established fisheries, AFMA has a policy for fishery exploration to support development of new commercial species. Fisheries Management Paper 5 sets out the policy and process for the exploration of Commonwealth fish resources. It provides information on the rights and obligations for operators wishing to establish and gain access to an exploratory fishery and aims to provide transparency and certainty for stakeholders involved in such a process.

Mitigation action taken by AFMA and industry, with the assistance of marine mammal experts and conservation group representatives, has been highly successful in reducing the gillnet interactions with Australian sea lions.

Since the Senate Estimates hearing in May 2013, there has been only one sea lion death reported in the gillnet fishery.
