Disclosure of information may be required by law or for specialised research projects that meet strict criteria and are approved by the National Livestock Identification System Cattle Advisory Committee and SAFEMEAT.

National Livestock Identification System data has, in accordance with the Terms of Use, been provided in response to subpoenas issued in relation to third party court proceedings and has otherwise been approved to be provided to research organisations under strict protocols for projects where a benefit to industry was established. Strict protocols required the data to be aggregated when published and all the information had to be carefully stored and deleted at the conclusion of the study. #### Senator RHIANNON asked:

- 1. Did MLA report to the Department of Agriculture that it was aware of widespread and systemic breaches of ESCAS relating to on-selling of animals occurring in Jordan?
- 2. Has MLA viewed the approved abattoir in Palestine?
  - a) Has MLA been requested to provide any training in this facility?
- 3. How many days training have MLA consultants undertaken in importing markets over 2013 AND which countries have MLA consultants travelled to in order to undertake training or gap analysis?
- 4. I understand that MLA has been reticent to report non-compliances within approved supply chains on the basis of believing action can be taken through training to address them. But where MLA becomes aware of Australian animals being sold outside of approved supply chains - will you commit to reporting these matters to the Department to ensure that action is taken to address this situation?

#### Answer:

- 1. No. Meat and Livestock Australia consultants were working only in approved facilities in Jordan, preparing systems for the Eid festival.
- 2. There are currently six ESCAS approved abattoirs in the Israel/Palestinian Territories (as of 3 October). Meat and Livestock Australia in partnership with LiveCorp through the Livestock Export Program (LEP), has been requested to provide training in Bakar Tnuva Abattoir, Dabbah Abattoir and Salech Dabach slaughterhouse.
- 3. YTD to the end of October 2013, MLA consultants have spent a total of 231 days in MENA, 141 days in Indonesia and 100 days in Other Asia markets. This includes training related activities ranging from formal to informal programs through to seminars and workshops. In 2013 training or gap analysis has been delivered in Brunei, Egypt, Indonesia, Israel, Jordan, Kuwait, Malaysia, Mauritius, Oman, Philippines, Qatar, Russia, Singapore, UAE and Vietnam.

#### Senator RHIANNON asked:

- 1. May I please have the following information regarding the period 1 July 2013 to 30 June 2014:
  - a) The total government funds budgeted for payment to match funding for levy investment in Meat & Livestock Australia (MLA) Research & Development projects?
  - b) How many projects have been funded to date?
  - c) How many projects have been published in peer reviewed scientific journals?
  - d) How many projects had the welfare of livestock as a primary aim?

What input does the Government have into the selection of R&D projects by MLA?

#### Answer:

- (a) \$36.1m in Government funding has been budgeted to match levy investment in Meat and Livestock Australia RD&E projects for 2013-14.
- (b) To date 625 projects have been funded in the period 2013-14 using Government funding to match levy investment in Meat and Livestock Australia RD&E projects. This includes ongoing and multi-year projects as well as new projects commenced in 2013-14.
- (c) Since 1 July 2013, 39 final reports for projects using Government funding to match levy investment in Meat and Livestock Australia RD&E projects have been published. Final reports for projects are published and made publically available on the Meat and Livestock Australia website. The findings from Meat and Livestock Australia funded projects can be published in scientific papers. To date in 2013-14, 17 papers have been published. In 2012-13 at least 140 papers were published.
- (d) 45 projects had the welfare of livestock as a primary aim.

Meat and Livestock Australia consults with peak industry councils during the development of the Annual Operating Plan (AOP) which details R&D and Marketing investment. The Department of Agriculture is provided with a draft of the AOP and is given the opportunity to make comments prior to the final version being published.
