Senator Boyce asked:

Please detail all education expenses (i.e. in house courses and tertiary studies) for each portfolio department and agency. Include the type of course, the cost and how many participants.

Answer:

In order to respond to the level of detail requested in the Question on Notice, the Department would be required to allocate extensive resources to gather this information. However, the Department has gathered centrally coordinated information relating to staff attendance at the various categories of training provided and total costs incurred is detailed in the following table.

The total cost for 2010–2011 for participation in the programs for which information has been collated to 31 May 2011 is \$5,322,942.67 (GST inclusive).

This cost covers internal and external learning and development activities, such as attendance at the Department's internal training and development programs, external conferences and seminars, and costs associated with staff undertaking tertiary studies through the study assistance program.

Some Land Councils, which have limited staff, have not been in a position to respond to this request, as the administrative burden to do so places unreasonable work demands on the small number of staff in these offices.
