## Answer:

The Central West Catchment Management Authority undertook the on-ground assessment of the property known as 'Razorback', located at 1462 Razorback Road, Sofala, New South Wales, on behalf of the Department of Sustainability, Environment, Water, Population and Communities, for the Environmental Stewardship Program's (the program) fifth funding round, which targeted Box Gum Grassy Woodland. Data from this site visit was recorded against specific criteria used in the assessment of bids under the program.

The collection of the data during site visits is based on a scientific methodology. It allows field officers to collect information to enable input into a computer-based decision support tool (metric) known as the Conservation Value Measure (CVM). The details from each site visit are entered into the CVM which calculates a Conservation Value Score (CVS) for each property. Each individual CVS is then divided by the bid price to provide a Conservation Value Index (CVI). The CVI is used to rank all bids received on a value-for-money continuum. A site assessment is mandatory for those that wish to submit an application for the program

## Senator Boyce asked:

- 1. In Queensland, bilbies are on the endangered list. How much money has been given to saving them in Queensland and to whom?
- 2. How much money has the Federal Government provided nationally to protect bilbies? Please provide information on the states that receive funding and the amount they receive?

## Answers:

 A national recovery plan for the greater bilby was adopted under the Environment Protection and Biodiversity Conservation Act 1999 in 2007 and is currently being revised. Within Queensland, the Department of Environment and Heritage Protection and the Department of National Parks, Recreation, Sport and Racing are the lead agencies responsible for coordinating the implementation of on-ground actions identified in national recovery plans.

Commonwealth Government funding is provided to Natural Resource Management organisations in Queensland through the Caring for our Country initiative. An objective of this funding is to address threat abatement activities that are outlined in recovery plans including the greater bilby recovery plan actions. In Queensland, there have been 19 projects totalling over \$5.5 million over the past five years of the Caring for our Country initiative that directly address threat abatement issues.

2. In addition to activities undertaken through Natural Resource Management business plans, over the past five years, three projects totalling \$1.17 million have specifically targeted the protection of bilbies.

- 1. Would you please provide a list of all conservation groups receiving federal funding?
- 2. Would you please provide a breakdown of funding to conservation groups received per annum?
- 3. Would you please provide a breakdown of how much of this funding for these groups goes into administration costs in dollar and per centage terms?
- 4. How much of this funding goes towards Australian iconic species?

#### Answer:

- The Department of Sustainability, Environment, Water, Population and Communities (the department) publishes details of individual grants, including all grants provided to conservation groups, on its website in accordance with the Commonwealth Grant Guidelines. - 2. The information published by the department on its website for each grant provided includes detail on the total value of the grant and the term of the grant per annum.
- 3. The amount of grant funding spent on project administration differs across programs. For example, the Caring for our Country Sustainable Environment stream: Target Area Grants 2013-14 imposes a 15 per cent cap on administration costs, which must include the costs of monitoring and reporting, while the Biodiversity Fund Round Two: 2013-14 imposes a 10 per cent cap on project administration costs and up to 5 per cent for monitoring and reporting. - 4. Over \$74 million will be invested through the Natural Icons and World Heritage budget of Caring for our Country during the first five years of the program, including \$10 million on efforts to maintain viable Tasmanian Devil populations. 5. The Minister for Sustainability, Environment, Water, Population and Communities makes the final decision on which projects receive funding, taking into account advice from the department and, for some programs, other relevant sources such as the Land Sector Carbon and Biodiversity Board.

The specific processes for developing advice vary slightly depending upon the program in question. Competitive grants rounds such as the Biodiversity Fund Round Two: 2013-14 and the Caring for our Country Sustainable Environment stream: Target Area Grants: 2013-14 are assessed by departmental staff and independent community representatives. Assessment panels are subsequently convened to review and confirm the merit scores of applications received. Each panel includes an independent Chair, external community assessors and departmental assessors. All panels comprise a majority of community members. Assessment projects being considered. An independent probity adviser is engaged to review assessment processes.

### Senator Boyce asked:

How much funding is spent on protecting Australian iconic species?

#### Answer:

The Australian Government funds the protection of Australian iconic species through, primarily, the Caring for our Country initiative. Under the first phase of Caring for our Country 2008-2013, over \$2 billion was invested in a broad range of projects, including those specifically targeting the protection of iconic species (for example, the Tasmanian devil), especially through the 'biodiversity and natural icons' theme. This funding was also spent on projects enhancing the natural environment and native habitat for Australian species. Under the next phase of Caring for our Country 2013-18, more than \$2 billion will again be invested in achieving environmental outcomes, including iconic species. Details of grants awarded through this program are available at www.nrm.gov.au.

The Australian Government's Biodiversity Fund is investing between 2011-2017 to enhance landscape resilience to climate change and improve habitat connectivity. Among other outcomes, this program is expected to have a positive impact on Australian iconic species through habitat improvement. Under Round One 2011-12, \$270 million was invested over six years to achieve improved environmental outcomes, including through projects positively impacting iconic species such as the koala. ## Senator Heffernan asked:

- In Senate Estimates the department advised an independent audit and a review into the property owned by Empire Property & Investment Group (1462 Razorback Rd, Razorback) was conducted and a further investigation is underway, when will the investigation into be completed?
- 2. Will you make it available to this committee? If so, please provide a copy.
- 3. Also, can we have a copy of the CMA Report that declared the property eligible and suitable for the Environmental Stewardship Grant?
- 4. Also can we see the certification paperwork and details of all expenditure of grant money given to this property as per guidelines?

### Answer:

 The Department of Sustainability, Environment, Water, Population and Communities (the department) sought an external and independent forensic audit of the grant received by Empire Property and Investment Group Pty Ltd and is following the recommendations of that audit.

The department is investigating this matter as a high priority. It is uncertain at this stage as to when the investigation will conclude.

- 2. As this matter is currently under investigation by the department and may involve a possible breach of the law and possible enforcement actions, release of the requested information at this time may prejudice those matters.
- 3. The department did not receive a formal inspection report from Mr Clayton Miller, Catchment Officer—Tableland, Central West Management Authority. The Central West Catchment Management Authority undertook on-ground assessment of the property known as 'Razorback', located at 1462 Razorback Road, Sofala, New South Wales, on behalf of the department, for the Environmental Stewardship Program's (the Program) fifth funding round, which targeted Box Gum Grassy Woodland. Data from this site visit was recorded against specific criteria used in the assessment of bids under the Program.

The collection of the data during site visits is based on a scientific methodology. It allows field officers to collect information to enable input into a computer-based decision support tool (metric) known as the Conservation Value Measure (CVM). The details from each site visit are entered into the CVM which calculates a Conservation Value Score (CVS) for each property. Each individual CVS is then divided by the bid price to provide a Conservation Value Index (CVI). The CVI is used to rank all bids received on a value-formoney continuum. A site assessment is mandatory for those that wish to submit an application for the Program

### Senator Macdonald asked:

In answer to Questions On Notice (Supplementary Estimates QON 005) from previous Estimates the Department has advised that \$200 million has been allocated to Reef Rescue initiative and that this funding is administered by – among others - the Department of Agriculture, Fisheries and Forestry.

DAFF QON 280 indicates that Reef Rescue funding for 2012-13 of \$51.5 million.

- 1. Can the Department indicate the time frame across which the stated \$200 million has been allocated/spent?
- 2. Can the Department provide any data to indicate specific programs and their outcomes that have been facilitated by the Reef rescue funding?

### Answer:

- 1. The \$200 million Reef Rescue program has been allocated/spent over five financial years from 2008/09 to 2012/13. Reef Rescue funding has been fully committed to activities that will improve the Great Barrier Reef's capacity to respond to the impacts of climate change.
- 2. Reef Rescue funding has been allocated toward the following program components:

### Water Quality Grant and Partnerships

- The Water Quality Grants and Partnerships program is delivered through a unique partnership with regional Natural Resource Management groups and peak industry bodies;
  - estimates of water quality outcomes for the first two years of the initiative are currently being produced via the Reef Plan 'Paddock to Reef Integrated Monitoring, Modelling and Reporting program'.
- To date more than 2,900 individual land managers have received water quality grants for on-farm projects;
  - this includes 2,000 farmers undertaking more than 3,200 projects over an area of approximately 780,000 hectares, exceeding the five year farmer engagement target of 1,300; and
  - more than 900 graziers have improved groundcover management over 2.7 million hectares through water quality grants and training, exceeding the five year pastoralist engagement target of 600 and representing 71 per cent of the grazing area target of 3.8 million hectares.

## Research and Development Program

The Reef Rescue Research and Development Program aims to improve understanding of the link between land management practices and environmental impacts, including those from major flood events, to improve the delivery of Reef Rescue.

- All 18 approved projects are progressing well and are on track to be completed by 30 June 2013.
- An independent research coordinator (the Reef and Rainforest Research Centre) is responsible for coordination and integration of research projects within the Reef Rescue program and with other related research initiatives.

## Monitoring and Reporting Program

- The program, delivered in partnership with the Queensland Government and the Great Barrier Reef Marine Park Authority, focuses on monitoring the catchment and marine environments through the Paddock to Reef Integrated Monitoring, Modelling and Reporting (Paddock to Reef) Program;
  - the program reports progress towards Reef Plan and Reef Rescue targets via annual report cards.

## Land and Sea Country Indigenous Partnerships Program

- The Land and Sea Country Indigenous Partnerships Program, delivered by the Great Barrier Reef Marine Park Authority, focuses on the development and implementation of Traditional Use of Marine Resource Agreements (TUMRA), compliance, and the strengthening of communications, knowledge sharing and engagement with Indigenous communities.
- The program is working with approximately 40 Traditional Owner groups within the Great Barrier Reef catchments through sea country management activities such as TUMRAs, Sea Country Partnerships grants and programs focussed on the transfer of Traditional Ecological Knowledge.

## Senator Macdonald asked:

Impacts on communities, commerce, flora and fauna from bushfires are being identified as an outcome that can be more effectively managed through fuel-reduction burns.

- 1. What data has the Department compiled through investigating the potential for changes to existing programs for fuel-reduction burns?
- 2. How much of this research has been conducted in Northern Australia (Nth QLD, NT and Northern WA)?
- 3. What changes will the Department be implementing to its fire-management strategies following reports and research into the mitigation of catastrophic fire events through fuel-reduction burns?

### Answer:

 The Department of Sustainability, Environment, Water, Population and Communities (the department) collects data through the annual reporting processes for the Working on Country initiative and Parks Australia protected area programs, including Indigenous Protected Areas, as well as through the Commonwealth funded North Australian Indigenous Land and Sea Management Alliance (NAILSMA) project detailed below. Details of funded projects through these and other programs are available at: www.nrm.gov.au.

Through Caring for our Country phase 2 and the Biodiversity Fund, fire related data will be collected through funding recipient reporting, robust ecological monitoring and remote sensing which will use satellite imagery to identify fire scars and other attributes.

 A \$9.1 million investment was made in Northern Australia (2008-2012) through a grant to NAILSMA to expand traditional fire management regimes across over 200,000km<sup>2</sup> of Northern Australia's savannas. Research work undertaken as part of the project resulted in the development of an approved methodology for Savanna Burning under the Carbon Farming Initiative.

A number of Indigenous Working on Country ranger groups continue to deliver early dry season fire management across Northern Australia as part of their work plans.

3. The department encourages the uptake of peer-reviewed science through its funding programs, including adaptive management practices which enable funded projects to adapt to changing conditions and catastrophic events.

While not owned or managed by the Commonwealth Government, all properties which have received funding support for their acquisition through the National Reserve System program element of Caring for our Country are required to be managed consistent with a management plan or interim management guidelines, which set out fire management strategies and processes for adaptive review.

### Answer:

- A total of \$177.6 million (GST exclusive) in Caring for our Country funding has been invested through the National Reserve System National Priority Area up to 30 June 2012. This investment has resulted in the addition of 17,895,633 hectares to Australia's National Reserve System through declaration of 26 Indigenous Protected Areas covering 15,603,907 hectares and support for 73 National Reserve System land purchases covering 2,291,726 hectares.
- 2. The Commonwealth Government remains committed to the National Reserve System and will continue to invest through the second phase of Caring for our Country in the marine component of the National Reserve System, the continuation of investment in Indigenous Protected Areas, and more broadly through the national biodiversity investment prospectus in strategic purchases of terrestrial properties. The progress under the first phase of Caring for our Country together with recent additions to the network of Commonwealth Marine Reserves, means that Australia is well on track towards meeting its commitments under Aichi Target 11.

### Senator Waters asked:

- 1. Regarding the Environmental Stewardship Program, is it not correct that after a temporary contract ends or a property changes hands there is nothing to stop a landholder reversing or neglecting whatever gains have been produced under the ESP in the absence of a covenant binding on the land title?
- 2. Why have so few of the ESP projects entailed a covenant?
- 3. What non commonwealth sourced co-investment in conservation has been leveraged by the ESP program?
- 4. Why is the ESP program nearly a hundred times more expensive on average than the National Reserve System program?

### Answer:

- Funding agreements are with individual grantees who are the leasee or freehold owner of the property. Funding agreements do not place any restrictions on the title of the property. However, the following condition is included in the template funding agreement which is publicly available at http://www.nrm.gov.au/funding/previous/stewardship/mecp/mecpsa.html:
  - 11. Disposal of the Land
  - 11.1 Disposal

Any Disposal of the Land other than in accordance with this clause 11 is a fundamental breach of this Agreement.

- 11.2 Procedure for Disposal of the Land
  - (a) If at any time during the Project Period:
    - (i) the Recipient proposes to Dispose of the Land or their leasehold interest in the Land; or
    - (ii) the owner of the Land proposes to Dispose of the Land,

to another association, body, individual or entity (the **Proposed Purchaser**), the Recipient must notify the Department.

- (b) The notice must:
  - be provided at least 60 days prior to the date the Recipient or owner of the Land wishes to make the proposed Disposal (unless otherwise agreed in writing by the Department); and
  - (ii) include the contact details of the Proposed Purchaser.
- (c) For the avoidance of doubt, the Recipient must ensure that the notice in clause 11.2(b) is provided prior to an instrument of Disposal being entered into.
- (d) Notwithstanding its termination rights under clause 23, on receipt of such notice the department may:
  - (i) seek to obtain the Proposed Purchaser's agreement to take over the obligations of the Recipient under this Agreement; or
  - (ii) seek to enter into an agreement with the Proposed Purchaser on substantially similar terms and conditions as those contained in this Agreement in which the Proposed Purchaser agrees to use the Specified Area for the same purpose and implement the Management Actions.
- 11.3 Recipient's obligations in relation to Disposal

Any Disposal of the Land in accordance with clause 11.2 is subject to the Recipient:

- (a) remedying any default of this Agreement prior to the Disposal;
- (b) disclosing to the Proposed Purchaser that there are the communities specified in Item 3 of Schedule 2 on the Land which are protected under the Environment Protection and Biodiversity Conservation Act 1999 (Cth); and
- (c) repaying the Funds in accordance with clause 6.7(b).

As the matters being protected and rehabilitated under the Environmental Stewardship Program are matters of National Environmental Signficance as listed under the *Environment Protection and Biodiversity Conservation Act 1999* (Cth) (the EPBC Act), they are subject to the protections afforded under the EPBC Act. Activities that are likely to have a significant impact on a protected matter may need approval under the provisions of the EPBC Act, irrespective of any requirements under the funding agreement in place under the Environmental Stewardship Program or any covenants in place over the land.

 The Environmental Stewardship Program has mechanisms in place to encourage applicants to consider entering into a conservation covenant. For example, applications to the program with covenants across the project site receive significant additional weighting during assessment. However, the choice to enter covenants remains a decision for individual applicants and land holders.

The Environmental Stewardship Program seeks to help address the long term protection of high value environmental assets. It complements the use of existing policy approaches such as regulation, grant programs, setting aside land in national parks and reserves and voluntary conservation on private land through covenants and other mechanisms.

- 3. Many participants in the Environmental Stewardship Program make a significant co-investment of time and funding, beyond what is compensated through grant payments, to meet the requirements of the program. Beyond the Australian Government investment in biodiversity protection on individual properties, there is a flow on benefit as neighbours and communities observe the benefits of changed approaches and of the conservation outcomes achieved by the program participants.
- 4. The Environmental Stewardship Program and the National Reserve System support biodiversity conservation outcomes. The Environmental Stewardship Program is focused on the protection and rehabilitation of matters of National Environmental Significance as listed under the EPBC Act. The focus of the National Reserve System is to conserve examples of natural landscapes and native plants and animals for future generations. Meeting these two different but complementary objectives is best achieved through differently designed programs.

The Environmental Stewardship Program under the Caring for our Country initiative provides long-term funding for private land managers to undertake management actions to achieve an ecological outcome, such as maintaining and/or improving the condition of a threatened ecological community. Grant payments include the cost of management actions as well as an amount for income forgone. The Environmental Stewardship Program is thus a payment to support active land management for the delivery of specific biodiversity outcomes.

Through the Environmental Stewardship Program, funding supports ongoing management actions and compensates for forgone income, which is an effective way of protecting vegetation remnants on agricultural land. Additionally, an aim of the Environmental Stewardship Program is to achieve enduring changes in land managers' attitudes and behaviours towards environmental protection and sustainable land management practices.

Australian Government funding provided under the National Reserve System supports the establishment of a network of reserves, through financial support for property acquisition. The objectives of the National Reserve System are delivered by the implementation of management activities detailed in Management Plans. There is no ongoing payment made for management activities. Ongoing costs of management activities can be greater than for land acquisition, which is recognised through the two thirds contribution made by the Australian Government towards the purchase cost for land acquisition.

A key finding from an independent review of the Environmental Stewardship Program, conducted in 2010 by Marsden Jacob Associates, found that the program "is an effective and efficient method of allocating public resources to conservation actions on private land at a low cost". Further, the review found that "while the reserves system achieves complementary objectives to the Environmental Stewardship Program, the reserves system is not a perfect substitute. Nor does it negate the need for programs such as the Environmental Stewardship Program."

### Senator Colbeck asked:

- 1. How much of the May 2012-13 Budget has been allocated to the Sustainable Environment stream of Caring for our Country?
- 2. What are the expected administrative costs for the Sustainable Environment stream of Caring for our Country?
- 3. How do these administration costs compare to last year?
- 4. How are projects that cross the Agriculture / Environment divide handled now that there is no longer a joint management team?

### Answer:

- The Sustainable Environment Stream of Caring for our Country commences with the second phase of the initiative in 2013/14. No funds are allocated to the Sustainable Environment Stream in 2012/13 under the first phase of Caring for our Country.
- 2. Funding for the administrative costs to deliver the Sustainable Environment Stream of Caring for our Country have not been set and is under consideration by the Commonwealth Government.
- 3. It is not possible to make a direct comparison between the administrative costs for the Sustainable Environment Stream of Caring for our Country and the first phase of Caring for our Country. The comparison is not possible because the Department of Agriculture, Fisheries and Forestry shared the administrative costs through the joint delivery arrangements for the first phase of Caring for our Country and because the administrative costs for the Sustainable Environment Stream of Caring for our Country have not been set.
- 4. Caring for our Country will continue to operate under joint governance arrangements, with the expectation that some components will also continue to be delivered jointly.
- 5. No. The Department of Sustainability, Environment, Water, Population and Communities anticipates some efficiencies will be derived from a more focussed delivery of the agriculture and environment priorities.

- Commemorating Eminent Australians (\$13,000, GST exclusive);
- Sharing Community Heritage Stories (\$1.4 million, GST exclusive); and
- Celebrating Community Heritage (\$281,000, GST exclusive).

## Senator Waters asked:

- 1. How much of the 2008 commitment of \$180m to the National Reserve System program has been committed to date?
- 2. How many hectares of new protected areas have been brought into the NRS as a result?

### Answer:

- A total of \$177.6 million (GST exclusive) in Caring for our Country funding has been invested through the National Reserve System National Priority Area up to 30 June 2012. A further \$3.8 million (GST exclusive) is approved for investment in 2012/13.
- This investment has resulted in the addition of 17,895,633 hectares to Australia's National Reserve System through declaration of 26 Indigenous Protected Areas covering 15,603,907 hectares and support for 73 National Reserve System land purchases covering 2,291,726 hectares as at 30 June 2012.
- 3. See answer to Question 1.
- 4. The Commonwealth Government remains committed to the National Reserve System and will continue to invest through the second phase of Caring for our Country in the marine component of the National Reserve System, the continuation of investment in Indigenous Protected Areas, and more broadly through the national biodiversity investment prospectus in strategic purchases of terrestrial properties.
- 5. Final decisions on the organisational structure of the Department of Sustainability, Environment, Water, Population and Communities will be made in the context of the 2013/14 Budget.

# Senator Whish-Wilson asked:

Senator WHISH-WILSON: ...In terms of the breakdown of how much money the Commonwealth has budgeted over forward estimates, would you be able to give an idea of what has been allocated specifically for the marine debris threat abatement plan?

Mr Oxley: That is a question I would need to take on notice.

# Answer:

Threat abatement plans provide a framework for guiding and prioritising threat abatement activities across a range of Government agencies and Non Government Organisations. The plans are not funding programs.

As previously advised (Supplementary Budget Estimates October 2012 Program 1.1 Question on Notice 044), through Caring for our Country and Water for the Future the Commonwealth Government has funded a wide range of activities to abate the threat of marine debris including gross pollutant traps, litter removal, education, removal of ghost nets (abandoned fishing nets), species protection from marine debris, and monitoring.

The Australian Government has committed \$2.2 billion for a second five years of Caring for our Country, commencing on 1 July 2013. The national biodiversity conservation prospectus, *One Land – Many Stories: Prospectus of Investment*, sets out the framework for Australian Government investment in biodiversity conservation under programs within the \$1.7 billion Land Sector Package and the sustainable environment stream of Caring for our Country. The Australian Government will continue to invest in activities that further protect Australia's urban waterways and coastal environments including:

- Supporting activities to reduce land based sources of marine debris in our urban coastal communities.
- Working with local governments, regional natural resource management organisations and relevant industries to reduce pollution entering into waterways.
- Supporting the trial, testing and piloting of innovative river and wetland health technologies.
- Implementing urban ecosystem improvements such as constructed wetlands, bio-retention basins, sediment basins, infiltration systems and buffer strips.

- Restoring riverbank vegetation and remediating other natural systems to reduce runoff in coastal catchments.
- Supporting local communities to manage, protect and restore urban waterways and coastal biodiversity and habitats and improve the connectivity of fragmented ecosystems.
- Implementing projects that reduce degradation and restore habitat around urban waterways to protect near-shore waters from runoff and other pollutants.
- Developing and implementing more targeted water quality improvement plans in high priority urban catchments.
- The management of land and sea country, including the development and implementation of management plans that complement and support corridor and natural resource management regional plans in the protection and management of biodiversity.

## Senator Whish-Wilson asked:

Senator WHISH-WILSON: In my questions on notice I asked about baseline data that you are using for the actual abatement plan. Can you provide specific information on the sources of the baseline data that you have used for the last four or five years? You said you allocated about \$7.1 million nationally for the threat abatement plan but can you provide the actual sources of where the data has come from?

Mr Oxley: I will need to take that on notice.

Senator WHISH-WILSON: What sort of data are you using to come a decision on number of marine vertebrates dying?

Mr Oxley: I have already indicated that I will take on notice the question about the underlying data which we have used.

### Answer:

There are a variety of data sources for marine debris which have been important in the listing, in 2003, of marine debris as a key threatening process and the development of a threat abatement plan in 2008/2009. The key threatening process and threat abatement plan documentation both contain references to these reports in their appendixes.

Historically, there has been a general lack of empirical base line data on marine debris. Since the listing of marine debris as a key threatening process, however, three ongoing data sources include the:

 Border Protection Command collecting of ghost nets – The Department of Sustainability, Environment, Water, Population and Communities (the department) tasks Border Protection Command to locate and where possible, retrieve ghost nets found at sea. This arrangement includes the collection of net samples of any ghost nets located. Every net retrieved lessens the impact on marine species and the net sampling is helping to build a better understanding of the types, and potential sources of ghost nets.

- GhostNets Australia's coastline work GhostNets Australia is an alliance of over 22 Indigenous communities from coastal Northern Australia. The program was established in 2004 with funding from the Commonwealth Government's Natural Heritage Trust (subsequently the Caring for our Country Program) and has supported Indigenous Rangers to remove over 7,500 ghost nets of varying sizes. This has resulted in the recovery of a proportion of the trapped wildlife, particularly marine turtles (52 per cent), and the prevention of the ghost nets from returning to the sea; and
- A joint Earthwatch Australia, CSIRO and Shell Australia TeachWild project which is undertaking surveys of debris and wildlife along the coast and in the oceans around Australia. The project is developing models from a variety of sources, including direct observations, to determine the potential impacts of marine debris on marine vertebrate populations (http://www.csiro.au/science/marine-debris).
- The arrangements with Border Protection Command and the CSIRO TeachWild project will also provide baseline information about the impacts on vertebrates of marine debris.

# Senator Colbeck asked:

- 1. Is it correct that DSEWPaC advice to Minister Burke regarding the then *FV Margiris* was that it would not have significant impact on matters of national environmental significance in a Commonwealth marine area?
- 2. If this is the case where does the uncertainty come in?
- 3. Was DSEWPaC aware of areas of uncertainty when they undertook the risk assessment?
- 4. If so, how could the risk assessment be completed with apparent gaps in the information?

## Answer:

On 3 September 2012, the Department of Sustainability, Environment, Water, Population and Communities (the department) provided advice to the Minister for Sustainabilty, Environment, Water, Population and Communities (the Minister) (B12/1514) on whether an agreement with the Minister for Agriculture, Fisheries and Forestry to commence a new strategic assessment of the Small Pelagic Fishery under Part 10 of the *Envrionment Protection and Biodiversity Conservation Act 1999* (the EPBC Act) should be pursued given the likely introduction of the *FV Margiris* to the Small Pelagic Fishery. That advice is available on the department's website at http://www.environment.gov.au/coasts/fisheries/commonwealth/pelagics/pubs/small-pelagics-assessment-brief1-2012.pdf.

The department's advice identified that there were uncertainties around the potential impacts on protected species arising from the introduction of a large mid-water trawl vessel with large scale, onboard processing and storage capacity above 2,000 tonnes that enables such a vessel to remain fishing for an extended period.
