Answer:

Section 116 of the *Water Act 2007* (the Act) states that:

"The staff necessary to assist the Commonwealth Environmental Water Holder are to be persons engaged under the Public Service Act 1999 who are:

- a) employed in the Department; and
- b) made available for the purpose by the Secretary of the Department."

As the Act does not allow for the establishment of a separate agency for the Commonwealth Environmental Water Holder, the Department of Sustainability, Environment, Water, Population and Communities has not undertaken detailed costings of such an arrangement.

- 1. On what sites and for what purpose has environmental water allocated this year been used?
- 2. How is water being used this year? On what sites?
- 3. How much do you expect will be carried over? What is the maximum that could be carried over?

Answer:

1. As at 31 January 2013, up to 1034.2 gigalitres of Commonwealth environmental water has been made available for use in 2012/13, with 751.2 gigalitres delivered. The table below shows approved watering actions for 2012/13 (as at 31 January 2013).

In addition, subject to trigger conditions being met, we can account for use of up to 157 gigalitres of Commonwealth environmental water associated with unregulated entitlements held in Queensland catchments.

- 3. The volume that is expected to be carried over is in the range of 300–600 gigalitres. The actual volume carried over will depend on environmental watering actions in the remainder of the water year and climatic conditions.

As at 31 January 2013, the maximum volume of water that the Commonwealth could carry over under limits associated with the entitlements was 1,098 gigalitres.

- 1. How much Environmental water is expected to flow into SA during 2012/13?
- 2. What were total flows on environmental water over the barrages? What is this as a per centage of water flowing through the barrages?
- 3. What were the tangible benefits to the lower lakes of this environmental water?

Answer:

- 1. An estimated 624 gigalitres of Commonwealth environmental water is expected to flow into South Australia during 2012/13.
- 2. The total flow of Commonwealth environmental water through the barrages during 2012/13 (as at 12 February 2013) is estimated at 355 gigalitres. This volume contributed approximately eight per cent of the total flows through the barrages.
- 3. Commonwealth environmental water contributed to:
- Improved water quality in Lake Albert where salinity levels have reduced to <3500EC (12 February 2013).
- Maintenance of connectivity between the Lower Lakes and Coorong, supporting continuous flows through the barrage fishways to enable the movement of freshwater and diadromous fish species.
- Maintenance of targeted water levels in the Lower Lakes improving connectivity to fringing wetlands.

Answer:

- 1. The Commonwealth Environmental Water Office will employ up to six local engagement officers.
- 2. The Commonwealth Government has committed \$4.934 million over seven years.
- 3. The local engagement officers will be based in regional locations in the Murray-Darling Basin (the Basin). The Commonwealth Environmental Water Office is seeking expressions of interest from relevant organisations within the Basin to assist with hosting these officers. The final locations of local engagement officers will be informed by responses to the hosting request.
- 4. Local engagement officers will work directly with people in Basin communities, seeking their views and knowledge on options for the use, delivery, monitoring and communication of results of Commonwealth environmental water. This information will inform environmental water management decisions.

Local engagement officers may also assist the community to develop water use proposals for consideration by the Commonwealth Environmental Water Office.

The local engagement officers will be active, visible and approachable in areas of the Basin, and will provide local communities with greater access to information about Commonwealth environmental water.

They may assist the Commonwealth Environmental Water Office with other water management functions such as providing information which contributes to watering options and decisions, informing communities of environmental water use actions, supporting monitoring and evaluation, and producing and contributing to communications materials.

State governments already have well established engagement with their local and indigenous communities and robust processes for determining environmental watering priorities and plans, consistent with community expectations and environmental requirements.

How does the CEWH intend to work within these well-established networks, without duplicating processes, creating another level of bureaucracy and further work for state-based catchment managers?

Answer:

Local engagement officers will be staff members of and report to the Commonwealth Environmental Water Office. They will work with existing state and local networks and processes where they exist, to seek the views of local communities. The Commonwealth Environmental Water Office is continuing to work closely and collaboratively with state agencies in implementing engagement arrangements.

I refer you to the "Discussion paper – Trading of Commonwealth environmental water" released in November 2011. That document was released for comment until May 2012.

Your website says: "The next step in the process will be the public release of a position paper with our responses to the issues raised in the submissions. This will inform development of operating rules which will establish the general framework within which trade will occur."

When will the position paper be released?

Answer:

The position paper is still being developed and will be released as soon as it is completed.

The position paper will include details of necessary safeguards that will be put in place to protect against the risk of insider trading, as required under the Murray-Darling Basin Plan. The Commonwealth Environmental Water Office will not trade until it is satisfied that it has the necessary safeguards in place.
