#### **Answer:**

1. The Low Carbon Australia Limited (LCAL) guidelines on study are set by the Board as part of LCAL Corporate Policies and Procedures. LCAL is committed to providing an environment in which employees are adequately equipped to achieve career and professional development needs relevant to their employment.

Studies assistance provides financial assistance for employees to undertake courses of study that will contribute to the improvement of their professional skills and knowledge relevant to their employment. Permanent employees of LCAL are invited to apply for study support for approved programs. Approved programs are those that relate directly to the employee's role at LCAL and will result in the development of the individual. Applications are assessed on a strictly discretionary basis and must be negotiated and approved by the Chief Executive Officer before study commitments are undertaken.

Staff members intending to undertake a course of study first discuss their plans with their supervisors to ensure that they correspond with work unit aims and that their study commitments can be accommodated within operational requirements.

The criteria under which applications are considered are the:

- strategic and operational needs of LCAL;
- impact of absences for study purposes on the workload of the work unit;
- effective work performance of the applicant;
- skills and specific knowledge required by the work unit;
- career and professional development needs of the applicant; and
- relevance of the course of study to the employee's employment within LCAL.

Employees who wish to apply for study support must have been employed by LCAL as a permanent employee for a minimum period of six months.

The decision to provide assistance and the form of the assistance to be provided to staff members will be on a case by case basis at the discretion of the Chief Executive Officer, taking advice of the Manager Human Resources.

LCAL will typically reimburse the cost of required text books for subjects undertaken.

Employees must have Manager approval prior to books being purchased, which will subsequently remain the property of LCAL. On completion of the subject the books will be kept in the Corporate Library for future use by LCAL employees.

Each employee will be entitled to one Study Leave day per subject unit, at Manager's discretion, and one Exam Leave day per subject unit or as otherwise agreed. A *Request for Leave* form is required, together with documentary evidence of the date and time of each exam.

LCAL will have no responsibility for any incomplete portion of approved study at the time of termination. Reimbursement of expenses incurred cannot be requested after termination.

An employee resigning or dismissed from LCAL will be required to refund 50 per cent of any financial support provided in relation to the previous 12 months immediately before the date of resignation (pro rata on a month by month basis). Payment will be automatically withdrawn from final salary payments. The above does not apply where retrenchment is involved.

Employees are requested to sign a 'Study Support Agreement'. The undertaking of study is a significant endeavour for both employee and company; therefore it is important that this effort is seen as a joint venture with shared responsibilities.

The ongoing provision of such financial assistance is based on the staff member achieving a minimum of a 'pass' in their chosen course. Expenses for retaking examinations will not be met by LCAL. Should a staff member discontinue the course before its conclusion, they may be required to reimburse LCAL for any financial assistance already provided.

Yes. Low Carbon Australia Limited's (LCAL) in-office printers calculate number of pages printed but do not identify whether the document fits the specifications asked for in the question. Providing an itemised account of every document that was printed on paper and classifying it according to whether it fitted into the categories asked for would present an unreasonable diversion of resources.

For documents printed externally, LCAL's main printing expenses are directed towards marketing materials such as product fact sheets. Providing an itemised account of every document that was printed on paper and classifying it according to whether it fitted into the categories asked for would present an unreasonable diversion of resources.

Even though LCAL has not conducted such an exercise, it is clear that there is a standout expense incurred for the type of documents cited in the question – this is for printing the Annual Report which cost \$17,200 in the 2011-12 financial year. The number of copies printed, and where they are delivered is mandated by the *Guidelines for the Presentation of Documents to the Parliament (Including Government Documents, Government Responses to Committee Reports, Ministerial Statements, Annual Reports and Other Instruments) June 2010.* Copies of these Guidelines can be obtained from the Department of the Prime Minister and Cabinet website at: <a href="www.dpmc.gov.au/guidelines/index.cfm">www.dpmc.gov.au/guidelines/index.cfm</a>. LCAL typically prints another 30 copies for use in-house.

- 1. The term "commissioning" implies a level of formality that does not always reflect the many ways that any information may ultimately end up being provided to members of parliament (MPs) and senators; such as:
  - by Low Carbon Australia Limited (LCAL) sending information to MPs and Senators as part of keeping the Parliament informed;
  - by virtue of the fact LCAL's Annual Report and/or other documents are tabled in Parliament:
  - by virtue of responses to Committees at Senate Estimates hearings and answers to Questions on Notice which are then printed in Hansard;

- by formal request through the Parliament using one of the many means available to any MP or senator or their staff;
- by formal request through ministers' offices or departments or the Parliamentary Library;
- by information supplied to departments or to ministers' offices that is then subsequently given to MPs or senators or their staff;
- by making the LCAL website available to the public; and
- by informal request by an MP, senator or their staff members.
- 2-4. As advised in the answer to part 1 above, most information provided to MPs and senators is not by way of formal request. Where it does come by formal request, LCAL takes the approach that it will provide Parliament with such information as it can reasonably provide on request. Where a request for information would require an unreasonable diversion of resources LCAL declines the request.

Apart from Senate Estimates Questions on Notice, LCAL receives few formal requests for information, and does not keep statistics on the origin of MP or senators' requests by political party affiliation (or non-affiliation). Capturing the kind of information asked for and collating the kind of statistics asked for broken down by political party affiliation (or non-affiliation) would not be a sound use of funding.

- 1. Low Carbon Australia Limited (LCAL) is a *Corporations Act 2001* public company under the *Commonwealth Companies and Authorities Act 1997*. It provides finance to Australian businesses, industry and government entities, either directly or through third-party finance providers.
  - LCAL's services are provided for under a Funding Deed with the Department of Climate Change and Energy Efficiency that specifies compliance with federal legislation covering unlawful discrimination as a condition of funding.
  - LCAL incorporates these conditions into its contracts with third-party co-finance partners where appropriate.
  - LCAL's Board-approved Corporate Policies and Procedures reflect the Company's stance on unlawful discrimination and all staff are required to familiarise themselves with this policy at induction and behave accordingly. This includes a well-developed complaints handling procedure.
  - LCAL's Code of Conduct requires staff to treat everyone with respect and courtesy and without harassment.

- LCAL operates a staff recruitment policy that is free of unlawful discrimination and has a culturally and linguistically diverse staff.
- LCAL has a formal process for handling complaints and issues raised in service delivery and for appropriate escalation of these. As part of the process, LCAL's Executive is informed of issues raised or any complaints and regularly reviews handling of any business arising.
- LCAL's physical sites are in wheelchair accessible buildings equipped with specific toilets for persons with disabilities.
- LCAL is at present rebuilding its online offering to ensure that its website and online materials meet accessibility requirements for persons who are vision-impaired and/or from a non-English speaking background.
