Senator MILNE: Maybe I could ask the minister. Is there any process through COAG to try to get some greater uniformity around the country on this question of an agreement about indemnifying to a degree or limit or whatever in relation to various states and local government?

Senator Wong: Not that I am aware of specifically, but I can take that on notice in terms of the various discussions. I do not recall in the context of the COAG that being on the agenda. I do not know if there is any other interjurisdictional ministerial council where this is being considered, but I will take it on notice.

Answer:

The Council of Australian Governments (COAG) Select Council on Climate Change (SCCC) is charged with developing national adaptation priorities for agreement by COAG and work plans for these priorities, as part of its Terms of Reference.

The SCCC held its inaugural meeting on 4 May 2012. At the meeting, the SCCC agreed to recommend seven national priorities for collaborative adaptation action to COAG:

- water resources;
- coasts;
- infrastructure;
- natural ecosystem;
- agriculture;
- emergency management; and
- vulnerable communities.

The SCCC also agreed that an Adaptation Working Group be established to develop work plans for the proposed national priorities. The coastal work plan will have an element on clarifying legal liability for local governments.
