- 3. It is not possible, without the diversion of significant resources to itemise individual expenses per visit. From available financial management records the total cost of overseas travel was \$512,977 (excluding GST) in the 2009-10 financial year.
- 4. In the current financial year up to 19 October 2010, 14 individual overseas visits have been undertaken by 10 departmental officials. As at 19 October 2010, future travel has been approved for four officials.
- 5. In the 2009-10 financial year 308 staff members made one or more interstate trips. During 2009-10, the Department's domestic accommodation and meals spend was \$1,882.981. This figure includes all travel related expenditure, excluding airfares.

For the 2009/10 financial year, the total cost of media monitoring, transcripts and press clipping services for the Agency was \$272,357 (ex GST). These services were provided by Media Monitors.

Australian Broadcasting Corporation

Digital Switchover communication

The Department continues the Digital Switchover communication campaign which was launched in April 2009. This involves an advertising campaign which includes a multiregional (national) and a local advertising component. Both of these components are based on key retail periods to ensure maximum cut through of messaging. The local component is based on advertising bursts that occur 6 months, 3 months, 3 weeks, 2 weeks, 1 week before switch off in a region and two weeks post. Since February 2010 local bursts have occurred in Mildura, regional South Australia and Broken Hill and Victoria. There have been two multiregional bursts of activity in March and September 2010. The communication campaign also involves a public relations component. The Department has engaged the consultancy n2n to conduct public relations / media activities. The Department has also engaged a Non-English Speaking Background and Indigenous consultant to reach these special audiences. The communication campaign budget for this financial year is \$25.4 million (excluding GST). This includes the National Call centre and campaign website. The campaign is anticipated to continue until all of Australia has switched to digital TV (December 2013).

NBN communication

An information and awareness campaign to inform Australians about the National Broadband Network initiative and provide information on the value of broadband to Australian society and the economy was launched on Sunday 13 June 2010. This involved a three week national advertising burst. The campaign uses television, online, press and indigenous radio advertisements and a website which provides more detailed information. In addition, community forum information sessions have been hosted across Australia to provide information in a more localised, interactive manner. The campaign has been allocated \$15.9 million (excluding GST) over two financial years (2009 - 10 and 2010 - 11).

Cyber Security Awareness

The National Cyber Security Awareness Week this year took place from 6–11 June. The Department underwent a select tender process to engage the services of a public relations consultancy (Quay Connections) for the National Cyber Security Awareness Week 2010. The total cost of the event was \$438,756 (excluding GST) that includes public relations consultancy, market research, stakeholder events and marketing products.

2010 Election

During the election the Government indicated it would proceed with auctioning the use of the 2.5 GHz band (2500-2690 MHz) spectrum in 2012-13. The Government expected to raise at least \$200 million that will be returned to the budget to help fund other government priorities.

As part of its work on spectrum management and allocation, ACMA had estimated that auction of the 2.5GHz band could generate \$200m. This was based on ACMA research on earlier international auction results for the band, and was provided to the Minister's Office in mid-2009.

The ACMA released a discussion paper in January 2010 outlining its proposed views on pricing, planning and licensing arrangements for the 2.5GHz band, and calling for comment. In October 2010, the ACMA published its response to the 42 submissions received to the discussion paper. ACMA's response and the submissions are available on its website. The discussion paper is the first stage in the process to prepare for the auction of the 2.5GHz spectrum with detailed implementation arrangements subject to ongoing consultation.

The Department is unable to comment on resources and spending as these issues are currently being considered within the Government's Budgetary processes.

The Department undertook an internal review of its property holdings in 2008 and proceeded with fitout rearrangements to meet the Department's objective of consolidating its three ACT tenancies into two tenancies in mid 2010. The Department's other office tenancy is located in Sydney's central business district.

The Department vacated one of its Canberra tenancies (the Burns Centre) in July 2010 upon expiry of the lease and sub-leased a smaller area adjacent to an existing tenancy completing its consolidation in Canberra into two tenancies; this enabled a move in the Department's occupational density toward the 16 square metres per occupied work point target; which aligns with the Governments direction on property and density targets.

The consolidation of leases has enabled a net savings to the Department in the order of \$500,000 per annum.

The Department of Broadband, Communications and the Digital Economy is working to develop a vibrant, sustainable and internationally competitive broadband, broadcasting and communications sector which promotes the digital economy for all Australians. A summary of two major programs - National Broadband Network and Digital Switchover as well as an overview of Funding Programs available during the lifetime of the current Government, is set out in the table below.

<u>Locational data</u> on key programs and funding/grant programs is held by program areas and has recently been centrally collated for an upcoming project to provide an online mapping resource. Where it has been possible, this data has been allocated on an electorate basis and summary details have been provided in the attached Electorate Information Sheets. Of course, many projects benefit multiple regions and electorates.

Grants listing on Departmental website From December 2007 the Government required agencies to publish the details of their individual discretionary grants on their websites within 48 hours of the announcement or awarding of the grant. From 1 January 2009 this has been replaced with a requirement for agencies to publish details of all grants on their website within seven days of the signing of the grant agreement. A grant is a sum of money given to organisations or individuals for a specified purpose directed at achieving goals and objectives consistent with government policy. - 4. The Department has not issued any conclusive certificates in relation to FOI requests.
- 5. Yes. As at 4 November 2010 the Department had received four FOI requests for its full Incoming Government Brief ('Red Book') and one request for part of the Incoming Government Brief. A decision on the request for the partial Incoming Government Brief was made on 29 October 2010 and documents were released to the applicant on 1 November 2010.
