Answer:

1. The calculation of savings for each agency related to the change in unit price (airfare price) based on the 2007-08 travel expenditure and travel pattern. The 2007-08 travel expenditure was discounted by 20 per cent to provide for any discrepancies in the source data; as such the savings were based on 80 per cent of 2007-08 travel expenditure. Further, a materiality test was applied so that only agencies with travel expenditure greater than \$1 million would be required to return savings to the Budget.

Additionally, a number of assumptions were made in relation to the availability of different fare classes, so that the cheapest fare was not the base fare for calculating savings. All agencies that were required to return savings were consulted on the model used to calculate the savings. The model was developed under the guidance of a cross-agency working group. Finally, agencies that were required to return savings to the Budget retained one-third of savings derived from the process.

The Department of Climate Change and Energy Efficiency (the Department) requested that the Department of Finance and Deregulation (DoFD) base their calculation of savings on our 2008-09 travel expenditure due to the fact that the Department did not exist for the whole of the 2007-08 financial year. DoFD agreed to do this and as the Department's travel expenditure is greater than \$1 million the Department is required to return savings to the Budget.

The changes require all *Financial Management and Accountability Act 1997* agencies to make travel arrangements through a Travel Management Company (TMC) that has been successfully appointed to the panel. Progressively agencies will approach the panel of TMCs over the next 12 months, to select their new provider through a simplified Request for Quotation process. The Department is due to approach the panel in March 2011.

Additionally, agencies, through their TMCs, have access to the discounted fares negotiated through the tender process as well as to any publicly available fare that may be lower than the negotiated fares.

The Department has implemented an online booking tool for domestic bookings which gives the Department access to discounted airfares and reduced transaction fees.

- 3. Yes. The range of airfares available is now transparent to officers booking travel and TMCs are required to assist agencies to select the Lowest Practical Fare. Additionally, there is now no preference for airline usage, and also agencies will not be required to undertake lengthy approaches to market.

- c) Facebook and other social media sites are used by some areas within the Department in an official capacity. Environmental and climate change social media sites are regularly reviewed for issues relevant to the portfolio.
- d) Staff are able to access social media sites. The majority of access comes under incidental personal use and is governed by the Department's internet access guidelines. Most access occurs at lunchtime.

- 2. The Department's staffing levels have increased since the 2007 election. Key factors influencing this include:
 - 199 staff being transferred to the then Department of Climate Change under a
 Machinery of Government (MoG) change on 17 December 2007. This included
 179 staff from the Department of the Environment, Water, Heritage and the Arts
 (DEWHA) and 20 staff from the Department of Prime Minister and Cabinet
 (PM&C);
 - the anticipation of the Australian Climate Change Regulatory Authority being established resulting in staff numbers increasing to 410 by the end of 2008-09, with further associated increases through the first half of 2009-10; and
 - the establishment of the Department of Climate Change and Energy Efficiency (DCCEE), with 418 staff being transferred from DEWHA under a MoG change on 18 March 2010.
- 3. The change in staffing levels associated with the creation of DCCEE has put pressure on the Department's budget. Staffing levels are managed within the overall resourcing available.
- 4. As outlined in the Portfolio Budgets Statement (PBS) 2010-11, funding for some of the Department's administered programs will not continue past the end of the 2010-11 financial year. This may have an impact on staffing levels but cannot be currently quantified. The current staffing levels reported in the PBS 2010-11 budget of 910 average staffing level remains correct at this time.
- 5. There is no current target for staff reductions to achieve savings.
- 6. Since Budget Estimates 2010, 86 staff have been employed on contract with an average length of 5.46 months.
- 7. Staffing numbers have not been directly reduced as a result of the current efficiency dividend and/or other budget cuts since Budget Estimates 2010.
- 8. There are no current plans for staff reduction.
- 9. Savings of \$150 million from the Renewable Energy Bonus Scheme Solar Hot Water Rebate program were identified and costed in accordance with the Charter of Budget Honesty. The savings relate to reducing administered program funding and have no impact on the Department or its staffing.

Mr Twomey—We did identify some breaches of the FMA Act and the FMA regs. I do not have the specific information here in front of me, but I can take it on notice.

Senator MILNE—Could you take it on notice. I would like to know what have been the consequences if breaches have been identified.

Mr Twomey—I will take that on notice.

Answer:

For the period 8 March 2010 to 30 June 2010 (i.e. the period the Green Loans program was administered by the Department of Climate Change and Energy Efficiency in the 2009-10 financial year), the Department identified six instances of non-compliance of incurring expenditure without *Financial Management and Accountability Act 1997* (FMA Act) Regulation 9 approval.

Note that the former Department of the Environment, Water, Heritage and the Arts was responsible for reporting any non-compliance for the Green Loans program for the period 1 July 2009 to 7 March 2010.

Each instance of non-compliance was a result of administrative oversight that was subsequently rectified once identified. The Department has implemented a number of remedial actions to address the non-compliance, including:

- implementing necessary approvals upon discovery of each instance of non-compliance;
- amending contracts to cover the additional work conducted and establishing a contract register;
- clarifying administrative arrangements and financial delegations with staff; and
- educating staff of the FMA Act requirements through formal training.

Each instance of non-compliance did not result in any adverse financial or operational consequences for the Department.
