Answer:

The emissions reductions announced with the Energy Efficient Homes Package were not targets, they were estimates based on the initial design of the package. It was estimated that cumulative emissions would be reduced by around 50 million tonnes by 2020 (not 2050 as cited by Senator Birmingham), and that emissions in 2020 would be around 4.7 million tonnes lower. It was assumed that 2.7 million homes would be insulated.

The most recent estimate was published in the *Intergenerational Report 2010*. Cumulative reductions by 2020 were estimated to be around 35 million tonnes. Annual emissions in 2020 were estimated to be reduced by 3 million tonnes, equivalent to taking about 800,000 cars off the road.

The Department is currently revising Australia's national emissions projections and will update the estimate for the Energy Efficient Homes Package in this process.

- risk-based sampling used to test claims and ensure high coverage of interim period; and
- Certificates of Currency for Insurance provided by installers.

The Department is currently investigating instances of non-compliance with the Terms and Conditions of the Home Insulation Program and will continue to implement actions that assist in identifying and investigating installer fraud.

- 3. The internal reporting of fires was not suspended during the course of the election. The number of confirmed house fires dropped during this period due to reconciliation of data, and this was not reported until after the election.
- 4. No.
- 5. The Department has received a number of claims. It would be inappropriate to comment in detail while these matters are being considered.

- 6. The Department has had reports of some injuries. It would be inappropriate to comment in detail while these matters are being considered.
- 7. The Department maintains relationships with all state and territory fire authorities. Staff also monitor media reports for fires and check with fire authorities with regard to cause and relationship to the Program.
- 8. Protocols around communication and reporting are in place with fire brigades. This allows timely reporting of incidents.
- 9. As far as the Department is aware, this question relates to state fire authority procedures and is not for the Department to comment on.

1. The 'Installation Pricing Table' was determined from an analysis of claims submitted to the Australian Government between 1 July 2009 and 20 August 2009, for the six most commonly used types of insulation (Cellulose, Glass Wool, Natural Wool, Rock Wool, Polyester and Foil). Further claim analysis occurred periodically to account for increased costs associated with fluctuations in supply and demand.

Straightforward Pricing Table – was modelled on claims for simple/straightforward installations requiring no unnecessary works (i.e. removal of debris, easy access to ceiling cavity, small area).

Average Pricing Table – was modelled on the average cost of all claims (inclusive of straightforward claims and complex/remote claims).

Complex or Remote Pricing Table – was modelled on claims for complex or remote installations (i.e. low ceiling installations, difficult access, remote/rural areas).

- 2. Assessment of expenditure against initial modelling prior to the commencement of the Home Insulation Program (the Program) shows that the cost of installing 1,164,888 properties under the Program is consistent with the cost of insulating the same number of homes outside of program conditions.
- 3. Industry estimates at the time of the Program's development indicated the cost of installation ranged between \$660 and \$1,600 per dwelling, depending on complexity. A study commissioned by the Insulation Council of Australia and New Zealand in June 2007 estimated the cost of insulating an average home would be around \$1,200.
- 4. The average cost of insulation under the Program between 1 July 2009 and 16 November 2009, was around \$1,440 (home-owner) and around \$1,137 (Low Emissions Assistance Plan for Renters).
 - The average cost of insulation under the Program between 7 November 2009 and 19 February 2010 was \$1,171.27.
- 5. As at 3 November 2010, the Department has received 1,164,888 claims, totalling around \$1.5 billion.

I refer to Conclusion 24 in the Auditor-General's report – "By November 2009, the volume of claims and increasing number of installations identified with quality, safety and potential fraud issues, overwhelmed the department and it was unable to recover the situation."

- 1. Was the department surprised at the volume of fraud and other problems that "overwhelmed the department", particularly given the original warnings to the Minister and Cabinet?

- 6. Were the Minister's actions entirely effective in stemming the fraud and safety problems?
