Answer:

- 1. During 2009-2010 the Department of the Environment, Water, Heritage and the Arts entered into a total of 168 new consultancy contracts.
- 2. The total value of consultancy contracts with a value of \$10,000 or more entered into in 2009-2010 was \$30.526m.
- 3. As part of mandatory reporting requirements, a complete list and detailed information (including the information requested) regarding consultancy contracts entered into in 2009-2010 with a value of \$10,000 or more is published in the Annual Report 2009-2010 and on AusTender.

As at 15 October 2010, the Department planned to conduct procurement exercises for 43 consultancy requirements for the remainder of the financial year 2010-2011.

As these consultancy requirements are in the planning stages, the Department is, for the majority, unable to provide information on the duration of the contract and the name of the supplier. In one instance the Department is able to provide the name of the proposed supplier and this is included in the table.

Parameters for the estimated cost of each consultancy have been provided based on planning as at 15 October and initial estimates of the value of the services. The Department cannot provide more detail in this regard until the procurement processes are finalised.

The Department has identified the proposed method of procurement for each planned consultancy. In doing so, the Department has adopted the AusTender contract reporting protocols for classifying the method of procurement. Procurements identified with a method of procurement as 'Direct Source' includes procurement processes where the Department may seek tenders or quotes from a number of suppliers.

- 2. The Department uses consultancy services for a wide range of purposes including environmental research, risk assessment and evaluation services. The selection and engagement of consultants is undertaken in accordance with the *Commonwealth Procurement Guidelines*.
- 3. A total of 44 consultancy contracts with a value of \$10,000 or more have been entered into since 25 May 2010. The details related to these consultancy contracts (including total contract values) are published on the AusTender website. The total value of the consultancy contracts entered into since 25 May 2010 is \$5.756m.

The total expenditure on consultancy services since 25 May 2010 to 3 November 2010 is \$8.201m. Of this amount approximately \$1.439m has been expended in the 2010-11 financial year (as at 3 November 2010).

- 4. The Department is up to date with its reporting requirements.
- 5. The Department's consultancy requirements often change in accordance with departmental planning and changing requirements and environments. Planning for consultancy services sits with individual outcomes and divisions and it is not possible to accurately detail any changes to planned consultancies since Budget Estimates without a significant diversion of resources.

There is a degree of uncertainty in the forecasting of many administered programs, especially those containing projects sensitive to climate conditions and complex planning and logistical arrangements, and those being managed by other parties.

Typically, significant anticipated funding adjustments, including the movement of funds from the current year into future years, are reflected at the Mid-Year Economic and Fiscal Outlook (MYEFO), Portfolio Additional Estimates Statements and Budget.

The Department will be reviewing the estimates for all programs prior to the 2011-12 Budget, when more information on experience will be available. A requirement to adjust estimates for underspends or overspends, particularly for administered programs, may be identified in this process.
