Senator Ludlam asked:

Senator LUDLAM—I understand that there are 337 places on the Commonwealth Heritage List and all of them are required to have management plans under the EPBC Act. Is that the case? Mr Shevlin—The Commonwealth has to use its best endeavours to encourage the development of a management plan.

. . .

Senator LUDLAM—How many of those management plans have been finalised?

Mr Shevlin—Of the 89 places we have on the list, 40 have plans that are finalised under the EPBC Act itself and a further five have draft plans that currently we are reviewing. There are about 24 places that have plans in place that were not made under the EPBC Act but that we believe provide entirely adequate protection—they were just made under state or territory legislation. There are 12 places that at the moment have plans under state or territory legislation—but we do not think they provide full protection for national heritage values yet.

Senator LUDLAM—Could you table what you are reading or as much of it as you are able to? That might be helpful.

Mr Shevlin—There is a whole lot of other information in there as well.

Senator LUDLAM—Could you table whatever is directly relevant to the question—some kind of breakdown of the progress to date of management plans? That might be handy rather than reading them out one by one because time is fairly short. ...

Answer:

Yes, Commonwealth agencies are required under s.341S of the *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act) to prepare management plans for places on the Commonwealth Heritage List (CHL) which they own or control. All of the 337 places currently on the CHL are required to have management plans under the EPBC Act.

Of the 337 places currently on the CHL, 107 (or approximately one third) have prepared or are preparing management plans (see Attachment A). Of these:

- One is fully compliant (Mawson's Huts Historic Site).
- One has been gazetted but has not completed the final stage of registration as a legislative instrument (Old Parliament House, ACT).
- 18 Commonwealth agencies have management plans that have received the Minister's advice, which includes comments by the Australian Heritage Council (AHC) but now need to be gazetted and to complete the final stage of registration as legislative instruments.

- Heritage Division has reviewed a further 38 management plans from the Department of Finance and Deregulation, Defence, this Department and a number of smaller Commonwealth agencies. These agencies are now required to submit the plans to the Minister.
- The Department of Defence has submitted 27 plans covering a total of 40 Commonwealth Heritage places to Heritage Division (some plans cover more than one listed place).
- Heritage Division has also received a draft management plan from the Australian Customs Service which is awaiting informal review.
- Heritage Division is working with Commonwealth agencies in the development of a further eight management plans.

Heritage Division will continue to work closely with key Commonwealth Government departments to ensure they prepare management plans to meet the standards of the EPBC Act.

The EPBC Act establishes two statutory heritage lists: the Commonwealth Heritage List (CHL) and the National Heritage List (NHL). Mr Shevlin provided information relating to the National Heritage List.

There are currently 89 places in the NHL (note that since October 2010, the Jordan River Levee (Tasmania) has been emergency listed and a separate emergency listing for The Tarkine (Tasmania) has now lapsed. Of these 89 places:

- 40 have plans made under the EPBC Act.
- 5 have draft plans made under the EPBC Act awaiting review.
- 23 have non-EPBC plans that are adequate.
- 12 have non-EPBC plans that do not adequately reflect NHL values.
- 9 have no plan in place. Of these:
 - 5 have some form of management arrangements;
 - 4 do not have management arrangements;
 - 2 are recently listed;
 - 1 is in preliminary discussions;
 - 1 has recently been contacted by the Department about preparing a management plan.

ATTACHMENT B STATUS OF MANAGEMENT PLANS FOR NATIONAL HERITAGE LIST PLACES

KEY POINTS

There are currently 89 places in the NHL (note that since October 2010, the Jordan River Levee (Tasmania) has been emergency listed and a separate emergency listing for The Tarkine (Tasmania) has now lapsed. Of these 89 places:

- 40 have plans made under the EPBC Act.
- 5 have draft plans made under the EPBC Act awaiting review.

- 12 have non-EPBC plans that do not adequately reflect NHL values.
- 9 have no plan in place. Of these:
 - 5 have some form of management arrangements;
 - 4 do not have management arrangements;

 - 1 has recently been contacted by the Department about preparing a management plan.

Places with finalised plans made under the EPBC Act

• 40 places have finalised plans made under the EPBC Act that will provide for the protection of the National Heritage values and other heritage values. There are a further seven places with plans made under the EPBC Act that are in a draft stage (see below).

Places with draft plans made under the EPBC Act, awaiting review

- 5 places have draft plans made under the EPBC Act that are awaiting review or amendment and finalisation. These are:
 - 1. Australian War Memorial and the Memorial Parade: Heritage Division has provided comment on a revised draft management plan for Campbell Precinct received in October 2009. The Australian War Memorial has released a draft plan for public comment.
 - 2. Batavia Shipwreck Site and Surveyor Camps: Heritage Division provided comment on a draft plan that addresses the National Heritage values in July 2007. The revised plan was due in 2008 but not yet received by Heritage Division.
 - 3. *High Court of Australia Former*: A draft plan addressing National Heritage values was prepared in 2005. Recent building editions necessitate revisions to this draft plan to satisfy EPBC Act requirements.
 - 4. *ICI Building Former (VIC)*: A non -EPBC Act plan is in place. An updated plan that addresses National Heritage values was received in March and reviewed by Heritage Division in August 2009. An amended plan is yet to be received.
 - 5 Point Cook Airbase: Currently under review.

Places with non-EPBC plans that are adequate

• 23 places do not have finalised plans made under the EPBC Act but do have plans made under State or Territory legislation which Heritage Division believes are generally adequate for the protection of the National Heritage values. Of these, two places also have draft plans made under the EPBC Act that are awaiting review or amendment and finalisation.

Places with non-EPBC plans that do not adequately reflect NHL values

ATTACHMENT B STATUS OF MANAGEMENT PLANS FOR NATIONAL HERITAGE LIST PLACES

• 12 places have plans in place that were made under State or Territory legislation and which Heritage Division believes do not adequately provide for the protection of the National Heritage values.

Places with no plans

- 9 places have no plan in place. However, five of these do have management arrangements in place.
 - 1. Dampier Archipelago (including Burrup Peninsula): Conservation Agreements made under the EPBC Act with industry are currently in place. The Western Australian (WA) Government is developing an Aboriginal Heritage Management Plan that will also protect heritage values.
 - 2. *Dinosaur Stampede National Monument:* Management arrangements were agreed at the time of listing. These will protect the National Heritage values.
 - 3. *Ediacara Fossil Site Nilpena:* Management arrangements have been agreed with owners to protect the listed heritage values.
 - 4. Flora Fossil Site Yea: The values are naturally highly protected as they are subterranean, embedded in rock strata. Management guidelines were developed in 2007 to protect the heritage values.
 - 5. *Myall Creek Massacre and Memorial Site:* Management arrangements are in place that protect the National Heritage values.

Places with no management arrangements:

- 6. Glenrowan Heritage Precinct: The site managers have recently been contacted again about preparing a management plan.
- 7. Wave Hill Walk Off Route: A preliminary discussion regarding management arrangements is underway with community stakeholders and the Northern Territory Government.
- 8. *Cheetup Rock Shelter:* This is recently listed and a plan is being prepared by the WA Govt that will address the listed heritage values.
- 9. *Jordon River Levee:* This is recently listed and the Tasmanian government is currently developing a Cultural Heritage Management Plan for the site as part permit conditions for the construction of the Brighton Bypass.
