#### **Answer:**

- 1. The Government is addressing housing supply through programs for affordable housing. These include the Housing Affordability Fund, the National Rental Affordability Scheme and the Building Better Regional Cities program. The Government is also developing a Sustainable Population Strategy to help address the economic, social and environmental implications of changes in Australia's population.
- 2a. Information on residential titles will be gathered with assistance from the Data Sub Group (DSG) of the COAG Housing Working Group a group of Commonwealth, state and territory government officials established to provide the National Housing Supply Council with information on potential land supply and demand.
- 2b. Information on this issue will be gathered with assistance from the DSG, the Australian Bureau of Statistics and relevant state, territory and local governments.

- 3. NRAS allocations and reserved allocations in NSW total 2,138. NRAS allocations and reserved allocations in Victoria total 4,348.
- 4. NRAS is a national scheme that calls for applications from across Australia. The number of allocations and reserved allocations offered across jurisdictions is the result of joint decision-making of the Commonwealth and states and territories about suitability of applications. Participation in NRAS in Victoria has been greater than in NSW due to the number of successful applications received for Victoria.
- 5a. Applicants make business decisions about a number of investment variables, including rental return, construction and investment costs and capital return. Around 87 per cent of Incentives allocated or reserved in NSW are for NRAS dwellings in major cities.
- 5b. There are currently no plans to amend or vary the Scheme.

# Senator Payne asked:

With regard to the travel budget of the National Housing Supply Council (answer to Community Affairs QoN 078 Budget Estimates):

- 1. What was the total travel bill of the NHSC for 2009-10?
- 2. Why was there a 17% increase in travel bills for the Council between 2008-09 and 2009-10 (to 31 May 2010)?
- 3. How much has the NHSC budgeted to spend on travel in 2010-11?

#### **Answer:**

- 1. Travel expenses, including flights, accommodation, cab charges, car hire and allowances, came to a total of \$124,402 in 2009-10.
- 2. An increase in travel expenditure from the 2008-09 to 2009-10 financial years was due to increased activities of the Council including meetings and consultations across different cities and in key regional areas.
- 3. Approximately \$150,000 is expected to be spent on travel related expenses in 2010-11.
