 - reduces level of staff time required to keep contact lists etc up to date.

The primary reasons for taximeter costs are as follows:

- LCAL is primarily based in Brisbane and services the country nationally from this base.
- Staff need to travel to secure business.
- Two LCAL staff are based in Sydney.
- Staff need to travel between Offices.
- LCAL does not operate a corporate fleet of vehicles.

- LCAL does not offer any car parks to staff.
- LCAL does not pay an allowance for vehicle purchase or leasing.
- Public transport schedules and services do not always suit travel or business arrangements.
- In many instances, taximeter services are a more effective use of funds that enables staff members to be more productive than if they were waiting for scheduled public transport services between meetings.

Circumstances in which staff access taximeter services are as follows:

- Staff member is travelling to or from airport.
- Staff member is travelling with luggage.
- Staff member is on interstate business.
- Staff member is attending a function on behalf of business.
- Staff member worked back late and caught taxi for reasons of personal safety.
- Staff member is called in and public transport was not readily available. For example, public holiday.
- Staff member or package delivery required to travel urgently or unexpectedly.
- Multiple staff travelling and cheaper to hire taxi than pay multiple scheduled public transport fares.
