Queensland has most of the Ports that ABARES say will bear the brunt of the new reserves, Mooloolaba, Cairns and Karumba. The exact impact can't be known yet, as SEWPAC doesn't know how many vessels will ultimately be removed due to reserve impacts (by licence and permit buy outs and also by resulting commercial pressures). However ABARES have documented that these Ports will be hardest hit. The Draft Fisheries Adjustment Package contains this statement: "Assistance for businesses upstream and downstream of directly impacted fishing businesses are not within the scope of the package. Such businesses have a demonstrated capacity to adjust to changing market conditions without government intervention." a. What economist evidence is there to prove this claim? b. The businesses are now not saleable; buyers and banks are aware of the impending major decline in seafood harvest and vessel numbers. Future expansion opportunities have been ruled out; there can be no growth in such businesses when there are few boats and nowhere left to expand fishing operations. The special plant and equipment is not usable in other sectors, so diversification is not possible. Given these large impacts, poor pro
