In response to ACMA request for Additional Information the following items are provided below.

1. The Noongar Media Enterprise is proposed as a subsidiary company Peedac Pty Ltd. The company type proposed is not for profit limited and to be registered under ASIC. It will operate in a manner similar to Jobtrain WA Pty Ltd, which is a subsidiary of Peedac.

The attached flow chart "Relationship Chart" explains the linkage between parent and subsidiary companies.

Attach information about how Jobtrain operates /relates to Peedac.

The Kaarta-Moorda Aboriginal Incorporation is the sole shareholder pf Peedac and its membership is drawn widely from the Perth Aboriginal community, all members of whom (over 18 years of age) are entitled to apply for membership. It is and open and accessible incorporated body that is required to comply with the commonwealth Aboriginal and Torres Strait Islander Corporation Act, recently amended.

The Peedac Board consists of two nominee directors (nominated from Kaarta-Moorda), the Managing Director of Peedac, and four other Aboriginal community members sourced from expression of interest process.

- 2. Upon receipt of advice from ACMA late this year or in early 2008, we will apply for funding to DCITA, DOIR and the Community Broadcast Foundation.
- 3. The expected timeline for establishing the radio station.

- 4. We do not yet have a Constitution, however, we have considered the objects of the Noongar Media Enterprise as set out in our draft plan include the following:
 - (a) To provide Noongar people with a media that recognises, respects and affirms our distinct identity and inherent rights and responsibilities in Australia society as Noongar people;
 - (b) To protect and promote the human rights of all Noongar people, which includes the Noongar women, youth and children whose interests must be acknowledged and respected at all times;
 - (c) To produce and broadcast an independent news and current affairs programs that address issues of importance to the Noongar and Aboriginal people, and which also recognize our connections with Indigenous peoples worldwide;
 - (d) To assist and support the revival and maintenance of the Noongar language and cultural identity through the broadcast of Noongar language programs;
 - (e) To promote and highlight Indigenous music and musicians;
 - (f) To support the Noongar representative organizations, particularly in the areas of health and healing, law and justice, the arts and music & education and employment, through their direct involvement;
 - (g) To ensure the active participation of the members of the Noongar community in the affairs of the Association and in accordance with the Community broadcasting radio code of practice;

- (h) To ensure the employment and professional development of Noongar people at all levels including management, production, broadcast, and administration;
- (i) To provide professional training and traineeships in the areas of broadcasting production and journalism;
- (j) To recognize and promote the importance of volunteers who may be members of the Noongar and wider community;
- (k) To support the development of other forms of Indigenous media including Indigenous television and film.

In addition to the objects the Constitution shall set out the process for electrical and removing Directors, and standard company matters the "replaceable rules" of ASIC regulations. We attach the Jobtrain Constitution which adopts such matters.

- 5. The Noongar Media Enterprise does not yet have any programming, staffing or volunteer policy. However, we have been in discussion with the Department of Industry and Resources (DOIR), Aboriginal Economic Development Division who are supported We intend to undertake a comprehensive business plan which will include policy and procedures for the Noongar Media Enterprise incorporating existing community broadcast policy, and the industry standard set out in the CBAA Handbook:

- a) The management and operations of the proposed service will utilize advice as set out under the CBAA Handbook, covering matters such as insurance, programming, disputes, volunteers, marketing, music sponsorship. Peedac and Jobtrain already have staffing policies, OHS, training & professional development. We attach a copy Peedac's policy documents.
 - b) Upon advice from ACMA which may happen late this year or early next year. NME will apply for funding to DCITA and DOIR, and it is envisaged that initial funding will be available in the early year. We will immediately engage a consultant to fully develop our business plan, policies and procedures to be completed by may 2008.
- 7. The Noongar Media Enterprise will also have its own Board of Directors (up to seven) made up of two nominees, and other Aboriginal community members sourced from expression of interest process. This selection of Directors will follow the same process already adopted by Peedac's subsidiary Jobtrain, and is set out in the Kaarta-Moorda Constitution. Similarly, the Noongar Media Enterprise shall set out in its own constitution this process of the Directors

appointment. The appointment will be for three years which allows stability and policy implementation.

- 8. The Noongar Media Enterprise will form advisory boards drawing on expertise in the field of broadcasting and media. For example, we may form a youth advisory body made up of young people to encourage their participation in the station operations and programming. Other advisory boards would concern training broadcaster and their responsibilities, and programming content.
- 9. a) Members of the community will participate at an operational level as staff and volunteers, and also through the various advisory boards. Members of the programming advisory board shall be drawn from the board level, and also the wider community through the expression of interest process, and direct invitation to relevant organisations such as Abmusic.
 - b) Members of the community may at a three yearly interval nominate themselves as a Board Director, and expressions of interest may be sought by Peedac and Noongar Media when a vacancy arises. Station volunteers should also be encouraged to nominate for Board positions.
 - c) Members of the community will be invited to participate through an expression of interest process, with advertisement (flyers) through local community organisations. Members of the community with radio and media expertise will be invited directly to be a part of the advisory boards. These will be informal advisory bodies that will be established as need demands. A programming advisory body would be a permanent advisory body comprising staff, volunteers and others community members.
 - d) Members of the community will be able to join the Kaarta-Moorda Incorporation; however the Noongar Media enterprise will not have its own direct membership.



Corporate Structure - Peedac Group.

Ownership Structure

The Kaarta-Moorda Aboriginal Corporation (the Corporation) is a community based, not for profit organisation. This is a policy making organisation which consults with its members, participants and the wider community on matters related to the needs in Perth. Membership is open to all Adult Indigenous people living within the Perth metropolitan region, in accordance with the KMAC constitution. The Corporation is the sole shareholder of Peedac Pty Ltd (the Company) which is an Income Tax Exempt Charity. It is this not-for-profit company, its Board of Directors and staff, which has direct control of the day-to-day operations of Organisation, focussing on the communities 'economic development' needs,. Working closely with the Kaarta-Moorda Aboriginal Corporation, it manages the finances and carries out the administration of the program.

The Diagram below shows this structure and describes the relationships between the Governing Committee of the Corporation and the Board of Directors of the Company.





Noongar Media Enterprise


Ownership Structure

The Diagram below shows the structure of the two companies. It illustrates the relationships between Peedac Pty Ltd and its proposed subsidiary company "Noongar Media Enterprise Pty Ltd".

Noongar Media Enterprise will set up a number of Advisory Boards to assist with the development and ongoing operations of the Radio Station. The Advisory Board members would be drawn from a number of sources, from the community, volunteers, and industry experts. Noongar Media Enterprise will report quarterly to Peedac Board of Directors on the matters of interest. Peedac will update KMAC regularly on activities of NME, especially matters requiring community consultation and future developments.



Aboriginal Radio has a long and important history here in Western Australia and plays a vital role in the process of self-determination by ensuring that our people not only have a voice, but also have access to culturally relevant information and issues.

By ensuring that this licence is allocated back to the Aboriginal community, we will once again have an important forum in which news and information can be broadcast, Aboriginal culture, music and language can be promoted and celebrated, and we can all share in the discussion of issues that impact our lives and our future here in this State.
