- 2. The Trust's communications program in 2008-09 has a budget of \$577,051. The budget comprises three main areas: marketing and publicity (advertising, signage, websites etc) \$162,000; events \$295,599; and publications (graphic design, photography, printing, etc) \$119,492.

Media advertisements are divided into the following categories, with the cost spent in each category in FY 2008-09 to date:

- a. Advertising tenders: \$9,843.57;
- b. Advertising general (i.e. property leasing, visitor programmes, events): \$33,587.19; and
- c. Advertising Community Consultation: \$10,164.07.

Advertisements are placed in a range of publications, including the Sydney Morning Herald, local newspapers, visitor guides, and a range of websites, mainly for tourism and children's activities. Very few advertisements are placed in national or interstate media.
