Answer:

The Department has undertaken the following communications programs since Additional Estimates (8 February 2010):

1. Shout Out For Climate Change Schools Competition (May – October 2010)

The Department is currently running a national schools and universities competition called *Shout out for Climate Change*.

This year's competition builds on the success of the 2009 *Think Climate*, *Think Change* schools competition and invites primary, secondary and tertiary students to submit a creative piece to raise awareness or encourage the community to take action to address climate change. A suite of classroom resources for primary and secondary teachers has also been developed to complement the competition. Resources are available on the competition website.

To date, the Department has spent a total of \$198,138.83 (excluding GST) to develop and administer the competition. This includes \$70,321.50 (excluding GST) for the design, development and maintenance of the competition website, and \$127,817.33 (excluding GST) for the development, design and production of competition collateral, and promotion of the competition through social media channels.

Additional spending for the competition is expected to be approximately \$115,000 (excluding GST), comprising:

- competition administration including moderating and judging of entries, responding to enquiries, designing and implementing a digital marketing strategy and general promotion of the competition \$50,000 (excluding GST);
- competition website and entry moderation \$20,000 (excluding GST); and
- awards ceremony and prizes \$45,000 (excluding GST).

2. Climate Change Foundation Campaign

The Department has undertaken development work on the *Climate Change Foundation Campaign* to provide Australians with the information they need to better understand and respond to climate change.

To date, the Department has spent a total of \$338,783.10 (excluding GST) developing the campaign, comprising:

- creative concept development \$206,906.46 (excluding GST);
- market research \$109,647.36 (excluding GST); and
- public relations \$22,229.28 (excluding GST).

The total budget for the campaign is approximately \$30 million.

3. Australian Football League sponsorship

The Department and the Australian Football League (AFL) entered into a partnership of \$200,000 for 2009-10 to help promote positive climate change actions to national and local Australian Rules Football clubs, players and fans.

The final activity under the partnership was conducted in June 2010. This included:

- the distribution of a promotional kit to all Australian Rules Football clubs in Australia for World Environment Day (5 June 2010); and
- the establishment of the Green Clubs program www.aflcommunityclub.com.au.

The total amount spent by the Department was \$200,000 (excluding GST).

1. For the financial year 2009-10, the Climate Change and Energy Efficiency Portfolio (which includes the Department of Climate Change and Energy Efficiency and the Office of the Renewable Energy Regulator) paid 80 per cent of accounts to contractors/consultants within 30 days. The on-time payment rate increases to 85 per cent when including all payments to small enterprises.

As the Portfolio's financial functions have matured, there has been an improvement in the timeliness of payments. In 2007-08, 73 per cent of invoices were paid within 30 days, and in 2008-09, 77.5 per cent of invoices were paid within 30 days.

The Portfolio continues to monitor its performance in relation to the timeliness of invoice payments and intends to further improve processes to reduce the average timeframe in which invoices are paid, including revising financial processes, increased education of staff and increased use of credit cards.

I note in the middle of the document it states: 'The process of redeployment will be supported by formal guidelines that have already been reviewed by the staff consultative committee and agreed.' When were those guidelines drawn up and when did the staff consultative committee meet to agree them?

Dr Parkinson—I can take that on notice, but Ms Weir might be able to assist. To be clear, these are a set of change management guidelines that had been in preparation for quite some time within DCC about how we would manage change in the event of it, so if not related to this then they carried across to DCCEE and they were worked on there. They were not designed specifically for the instance that we confronted but designed to allow for any type of circumstance.

Ms Weir—I believe we are referring to the managing change protocols document. That was the subject of significant consultation with the relevant unions and with our staff consultative committee over a period of some weeks. We also had a discussion about that document at a meeting of the SCC. The document was in existence and close to finalisation. I need to take on notice the date of that signing off, but the document was in train and had been through a process at the time of the staff note. I will take on notice the exact dates of that process. Dr Parkinson—We will also find out when I met with the staff consultative committee, which was not long after DCCEE had been created. It predates the CPRS decision quite considerably, but the formal sign-off will be closer to the date.

Answer:

The Protocols for Managing Change including Restructuring, Redeployment and Retirement were initially prepared by the Personnel Operations Unit in February 2010.

Consultation within the Branch and with the First Assistant Secretary, Corporate Support Division, occurred until the document was forwarded to the Staff Consultative Committee members on 14 April 2010 for consideration out of session.

Senator BIRMINGHAM—Firstly, there is a part of my question you did not answer. In terms of the 10 per cent issue or whatever departure rate, what proportion of those are transferred to other departments?

Dr Parkinson—I would have to take that on notice. It depends very much—**Senator BIRMINGHAM**—I need something as approximate as the approximation you just gave Senator Marshall.

Dr Parkinson—I am able to give the approximation of around 10 per cent, because typically 10 per cent to 15 per cent are the sorts of turnover numbers that you see. But agencies go through cycles. After periods of disruption you often get higher departure rates. Things settle down. Departure rates stabilise. Where people go depends a lot on the skill-sets they have. If you typically think of a group of people, for example, macroeconomic forecasters, they do not tend to go to other agencies. They tend to go to the private sector. If you are thinking about generic policy development or program administration skills, your market might be much more other departments. We could have a stab, but that is all it would be and I would really have to have a look because off the top of my head I do not know, and I do not know whether Ms Weir knows, where our departures have gone.

Senator BIRMINGHAM—I am happy for you to provide the answer in detail, but as Senator Abetz said, what is the stab—and subject to correction?

Dr Parkinson—I was just asking if we have any data at all.

Ms Weir—We do not collect information on where people transfer to. We do know people transfer across within the public service, so we could provide that. But we do not collect it in any more detail than that.

Answer:

The attrition rate for the Department for 2009-10 is 13.8 per cent. Of the 145 cessations from the Department from 1 July 2009 to 30 June 2010, 48 staff – or 33 per cent – transferred to other Commonwealth agencies.

Answer:

As at 31 August 2010, the Department of Climate Change and Energy Efficiency was responsible for leases in four buildings, being:

- 2 Constitution Avenue, Canberra, ACT:
- 20 Allara Street, Canberra, ACT;
- 1 Farrell Place, Canberra, ACT; and
- 5 Farrell Place, Canberra, ACT.

Departmental staff occupied space in 1010 La Trobe Street, Docklands, Victoria which is controlled by another Commonwealth agency.

The Department also occupies space within the Secretariat of the Pacific Regional Environmental Programme Headquarters, Avele Road, Valima, Apia, Samoa.

In February 2008, a tenancy Australian Building Greenhouse Rating (ABGR) assessment was conducted on the space currently occupied by the Department of Climate Change and Energy Efficiency at 2 Constitution Ave. A rating was not obtained at that time because there was insufficient data available relating to the Department's energy use. The assessment did identify measures that may assist in improving the environmental performance. The following recommendations have been initiated:

- the lighting system has been placed on timers (within the limitations of the system currently installed in the building);
- the Department purchases electrical appliances with the highest energy rating available;
- the time of operation for the supplementary air-condition systems in the meeting rooms has been reduced; and
- the Department has internal policies limiting the use of printers and other appliances.

5 Farrell Place construction was completed in June 2007 to a design minimum of 4.5 Star AGBR. The building incorporates an advanced HVAC system which is controlled by the latest generation Building Management System (BMS) with highly efficient glass facade.

In the remaining premises, the Department's presence is either on a short term basis or the area occupied is not significant. However, the Department has implemented energy saving measures similar to the above at these sites wherever possible.
