Answer:

- 1. Funding in 2010-11 is to meet the cost of paying rebates for outstanding pre-approved solar power system installations, once installation reports are provided to the Department.
- 2. The funds are used to pay rebates for pre-approved solar systems installed in accordance with SHCP program rules.
- 3. The initial pre-approval process was longer than usual due to the large influx of applications in the final weeks of the program. Approximately 70,000 applications were received from early May 2009 through to the closure of the program to new applications on 9 June 2009. These applications had to be checked, matched and processed before applicants were notified of the result. The majority of pre-approvals were granted on 6 October 2009.

Applicants have nine months to install their systems. Once installation is complete, applicants have eight weeks to provide a correctly completed installation report to the Department.

4. At 31 August 2010, it is estimated that there are less than 4,500 pre-approved solar systems still to be installed.

5. As of 31 August 2010, there were 2,378 installation reports to be processed. SHCP is currently processing correctly completed installation reports in less than five weeks from the date of receipt. Once installation reports are approved, it takes up to two weeks for rebate payments to be made. Current processing and payment times are within the target processing timeframe of six weeks indicated in the SHCP program guidelines.

Senator XENOPHON asked:

- 1. Given that many small businesses and individuals outlaid large amounts of their own money or went into debt to undertake training to become assessors, how does the Government intend to compensate them now that their businesses may not be viable under the changes made to the scheme?
- 2. What changes has the Government implemented to ensure that assessors are paid within suitable timeframes?
- 3. Are there any alternative employment options in the field available to people who have trained as assessors under the scheme?

- 1. The decision to seek to become an accredited assessor has always been an individual, commercial decision. Assessor contracts make it clear that there is no guarantee of work under the Program.
- 2. The Government has increased staffing and improved internal business processes to improve invoice processing times. As a result, as at 31 August 2010, all correctly rendered invoices are being paid within 30 days, as per Government policy. Correctly rendered invoices have been paid within the 30-day timeframe since May 2010. Information on payment timeframes is available and regularly updated on the Green Loans Program website.

- 3. On 8 July 2010, the Minister for Climate Change, Energy Efficiency and Water announced that the Green Loans Program would transition to a grants-style Green Start Program later in 2010. Round one of this Program will provide employment options for assessors with grants to be awarded through a competitive process to accredited assessors and organisations who can deliver high quality energy assessments.
- 4. As a part of the targeted stakeholder consultation being undertaken to inform the design of Round one of Green Start, the Government will consider transitional arrangements.
- 5. The Government notified the Association of Building Sustainability Assessors (ABSA) about the changes to the Green Loans Program on 19 February 2010. ABSA was notified of the changes prior to the public announcement.
- 6. The Government took into account the number of available assessments when setting the caps on contracted assessor numbers, and daily and weekly assessment bookings, as announced on 19 February 2010.

These funds were retained in the Portfolio Budget Statements (PBS) pending finalisation of costs for safety inspection programs and Industry programs after the Home Insulation Program was terminated in February 2010. These were best estimates at the time the budget was prepared, and will be subject to refinement.

Mr Thompson—In terms of the assertions about concerns raised within the Construction and Property Services Industry Skills Council.

Senator ABETZ—A number of dates, but as I understand it, these sorts of competency units—if that is the correct term—are usually developed over a period of 18 months, and this one was pushed and shoehorned into about six months; is that right?

Senator Wong—No. The reason this is not ringing many bells for Mr Thompson—he has given you some information—and the reason I was inquiring about dates or a little more information was so that we could perhaps be clearer in terms of the question on notice. We will take the question on notice. If you are able to provide any more information about that issue to assist us we would appreciate it, because the officers are not advising me of anything that I think accords with what you have put on *Hansard*. We will certainly make enquiries. **Senator ABETZ**—When this *Hansard* comes out, I can go back to my sources and they will undoubtedly provide further information. I will leave it there. Thank you very much, Chair.

Rectification of the safety issues was undertaken by a licensed electrician under the Department's Home Insulation Safety Program (HISP) on 10 June 2010. The inspectors have assessed that the Qureitem's ceiling space was safe in relation to the insulation installation following rectification work.
- 2. Please see response to part 1.

- 3. Where safety issues are identified during an inspection, the Department is notified within 24 hours. The Department requests the rectification through a government-contracted licensed electrician within two business days. Electricians are asked to contact the householder within one business day to arrange a time and date for the rectification work. The actual date of rectification work is at the householder's discretion.
- 4. When a safety issue related to the installation of insulation is identified, the Department arranges and pays for rectification under the HISP. Checks are in place to ensure that HISP inspectors and rectifiers are not associated with the original installation.

- 7. No. However a small percentage of homes are reinspected for quality assurance purposes. In these cases, the Department will arrange the inspection through its inspection service provider.
